OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

HOW TO ENTER

1. These rules govern the “The Heineken Tony Grossi Shootout Northeast Factory Direct Foursome Giveaway” promotion (the “Promotion”) being conducted by ESPN Cleveland & Good Karma Broadcasting (“GKB”) beginning on Friday, August 25, 2017 at 3:00pm ET and ending on Friday, August 25, 2017 at 5:00pm ET.
2. To participate in the Promotion, you may call in to The Next Level studio line (216-578-0850) once the contest is announced on-air and opened up for callers. Emmett Golden and Jerod Cherry will play “Martin Trivia”, a TV show trivia game, on Friday, August 25, 2017 by selecting callers in chronological order as they come into the show. Jerod Cherry will read questions to Emmett Golden and the caller has to guess if Emmett Golden will get the question right or wrong. If the winner guesses correctly two (2) times, he or she will win one (1) foursome for The Heineken Tony Grossi Shootout on Tuesday, August 29th, 2017. If the caller guesses incorrectly, Emmett Golden and Jerod Cherry will select the next caller on the line.

ELIGIBILITY RESTRICTIONS

1. The Promotion is open to all persons who are 21 years and over and who reside in the state of Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB’s advertising and promotional agencies, its participating sponsors, other radio stations in the Cleveland metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
2. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every thirty (30) days and only once every six (6) months if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.

PRIZES

The Approximate Retail Value ("ARV") is \$600 for the total foursome.

The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

WINNER SELECTION AND NOTIFICATION

1. Decisions of GKB management with respect to the Promotion are final.
2. Emmett Golden and Jerod Cherry will play Martin Trivia, a TV show trivia game, on Friday, August 25, 2017 by selecting callers in chronological order as they come into the show. Jerod Cherry will read questions to Emmett Golden and the caller has to guess if Emmett Golden will get the question right or wrong. If the winner guesses correctly two (2) times, he or she will win one (1) foursome for The Heineken Tony Grossi Shootout on Tuesday, August 29th, 2017. If the caller guesses incorrectly, Emmett Golden and Jerod Cherry will select the next caller on the line.
3. The winner(s) will be selected on Friday, August 25, 2017 by 5:00pm ET.
4. Odds of winning the prize depends upon the number of calls received.
5. Winner will be notified through the show on Friday, August 25, 2017 by 5:00pm ET to confirm eligibility. 5. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
