

2018 Cavs vs. Heat Ticket Giveaway
OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

HOW TO ENTER

1. These rules govern the 2018 Cavs vs. Heat Ticket Giveaway promotion (the "Promotion") being conducted by ESPN Cleveland, 1301 E 9th St Suite 252, Cleveland, OH 44114 ("GKB") beginning at 9:00am on Monday, January 22, 2018 and ending on Thursday, January 25, 2018 at 5:00pm.
2. To participate in the Promotion, you may enter via the following method(s): Listen to ESPN 850 WKNR beginning at 9:00am on Monday, January 22, 2018 and ending on Thursday, January 25, 2018 at 5:00pm. Follow the instructions given by the show host for how to win the contest. Four winners will be selected to receive tickets throughout ESPN 850 WKNR local programming.
3. GKB is not responsible for telephone service outages, delays, equipment malfunctions or any other technological difficulties that may prevent an individual from entering the contest. GKB is not responsible for any fees incurred by an entrant for this method of entry.
4. One entry per listener.

ELIGIBILITY RESTRICTIONS

1. The Promotion is open to all persons who are 18 and older and who reside in Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in the Cleveland metropolitan area and the members of their immediate families (spouse, parents, siblings, or children), significant others, and/or households (whether related or not) are ineligible to participate or win. Winners will be selected between 9:00am on Monday, January 22, 2018 and Thursday, January 25, 2018 at 5:00pm.
2. The Approximate Retail Value (“ARV”) of the pair of Cleveland Cavaliers tickets awarded in this Promotion is \$100. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.
3. All prizes or prize certificates may be picked up at the office of GKB at the address below. The winner will forfeit any prize or prize certificate not claimed within thirty (30) days of winning. 3. Winner(s) will be notified between Monday, January 22, 2018 at 9:00am EST and Thursday, January 25, 2018 at 5:00pm EST. Odds of winning the prize depends on the number of entries received.
4. The winner(s) must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited and an alternate winner may be selected by random selection from all entries. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.
