

**2018 Cleveland Monsters vs. San Diego Gulls (Saturday) Ticket
Giveaway**

OFFICIAL RULES

HOW TO ENTER

1. These rules govern the 2018 Cleveland Monsters vs. Chicago Wolves Ticket Giveaway promotion (the "Promotion") being conducted by ESPN Cleveland, 1301 E 9th St Suite 252, Cleveland, OH 44114 ("GKB") beginning on Thursday, March 15, 2018 at 9:00am and ending on Thursday, March 15, 2018 at 1:00pm.
2. To participate in the Promotion, you may enter via the following method(s): Listen to ESPN 850 WKNR starting on Thursday, March 13, 2018 at 9:00am and ending on Thursday, March 13, 2018 at 1:00pm Follow the instructions given by the show host for how to win the contest. One total winner will be selected to receive four tickets to the Cleveland Monsters game on March 24, 2018 throughout ESPN 850 WKNR local programming.
3. GKB is not responsible for telephone service outages, delays, equipment malfunctions or any other technological difficulties that may prevent an individual from entering the contest. GKB is not responsible for any fees incurred by an entrant for this method of entry.
4. One entry per listener.

ELIGIBILITY RESTRICTIONS

1. The Promotion is open to all persons who are 18 and older and who reside in Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in the Cleveland metropolitan area and the members of their immediate families (spouse, parents, siblings, or children), significant others, and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
2. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every thirty (30) days and only once every six (6) months if the prize is

1. There will be a total of (1) winner in this Promotion. The winner will receive (4) tickets to the Cleveland Monsters game against the Chicago Wolves on Saturday, March 24, 2018 at 7:00pm EST. Winners will be selected between Thursday, March 15, 2018 at 9:00am and ending on Thursday, March 15, 2018 at 1:00pm.
2. The Approximate Retail Value (“ARV”) of the tickets awarded in this Promotion is \$160. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.
3. All prizes or prize certificates may be picked up at the office of GKB at the address below. The winner will forfeit any prize or prize certificate not claimed within thirty (30) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
4. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. WINNER SELECTION AND NOTIFICATION

1. Decisions of GKB management with respect to the Promotion are final.
2. Winners will be selected between Thursday, March 15, 2018 at 9:00am and ending on Thursday, March 15, 2018 at 1:00pm.

3. Winner(s) will be notified between Thursday, March 15, 2018 at 9:00am and ending on Thursday, March 15, 2018 at 1:00pm. Odds of winning the prize depends on the number of entries received.
4. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited, and an alternate winner may be selected by random selection from all entries. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.
5. If there is a tie between participants, a winner will be selected at random between the tied participants.

If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).

5. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
