

2018 ESPN Cleveland Fan Appreciation Party Contest

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

HOW TO ENTER

1. These rules govern the “2018 ESPN Cleveland Fan Appreciation Party” promotion (the “Promotion”) being conducted by ESPN Cleveland & Good Karma Broadcasting (“GKB”) beginning on Friday, December 15, 2017 at 9:00am ET and ending on Wednesday, January 10, 2018 at 7:00pm ET.
2. To participate in the Promotion, you may enter via the following method(s): Listen to any local programming show on ESPN 850 WKNR and call in via the studio line (216-578-0850) any time between 9:00am ET and 7:00pm ET during the contest run dates for your chance to win a spot in the 2017 ESPN Cleveland Fan Appreciation Party. You may also enter through tagging a friend on the Fan Appreciation Party social media posts on Facebook (ESPN Cleveland), Twitter (@ESPNCleveland), and Instagram (@ESPNCleveland). Winners on social media will be selected at random.
3. Spots will be given away any given time during the promotion dates and given away based on the show’s discretion.

ELIGIBILITY RESTRICTIONS

1. The Promotion is open to all persons who are 21 years an over and who reside in the state of Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB’s advertising and promotional agencies, its participating sponsors, other radio stations in the Cleveland metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
2. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every thirty (30) days and only once every six (6) months if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
3. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
4. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

PRIZES

1. One prize will be awarded in this Promotion. The prize consists of the following: One (1) spot for you and a guest to attend the 2018 ESPN Cleveland Fan Appreciation Party on Saturday, January 13, 2018 at Northfield Park.
2. The Approximate Retail Value (“ARV”) is not specified, because there is no set value.
3. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

WINNER SELECTION AND NOTIFICATION

1. Decisions of GKB management with respect to the Promotion are final.
2. All winners will be selected by Wednesday, January 10, 2018, at 10pm ET.
3. Odds of winning the prize depends upon the number of calls received and number of social media comments.
4. Winner will be notified over the phone during local programming shows between 9:00am ET and 7:00pm ET on any date from Friday, December 15, 2017, and Wednesday, January 10, 2018, to confirm eligibility. Social media entrants will be notified between 9:00am ET and 7:00pm ET on any date from Friday, December 15, 2017, and Wednesday, January 10, 2018, to confirm eligibility. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited. If winner has not confirmed eligibility via phone or email by January 11, 2018, at 5pm, alternate winner(s) will be selected. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

CONDITIONS

1. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner’s full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.
2. By participating in the Promotion, the winner agrees to have the winner’s name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
3. Prior to awarding any prize(s) or prize certificate(s), GKB, in its sole discretion, may require Promotion winner(s) (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless GKB, its subsidiary and affiliated entities,

their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.

If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
5. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
6. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.
7. GKB is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
