

2021 Delzer ESPN Milwaukee Open Giveaway

OFFICIAL RULES

CONTEST OVERVIEW

ESPN Milwaukee fans will have the chance to win an invite along with (3) guests to the 2021 Delzer ESPN Milwaukee Open on Tuesday, July 20, 2021. Fans may enter to win by submitting a video of themselves impersonating their favorite golfer on Twitter between Monday, June 21, 2021, at 12:00p CT and Friday, July 2, 2021, at 5:00p CT. Fans can submit their video by direct messaging the @ESPNMilwaukee Twitter account, commenting on @ESPNMilwaukee's post on Twitter, or create a post of their own tagging @ESPNMilwaukee on Twitter. There will be a total of (1) Grand Prize winner in the contest. The total ARV of the grand prize is \$700.

1. HOW TO ENTER

- a. These rules govern the 2021 Delzer ESPN Milwaukee Open promotion (the "Promotion") being conducted by WKTJ 94.5 ESPN Milwaukee, 720 E Capitol Drive, Milwaukee, WI 53212 ("GKB") beginning on Monday, June 21, 2021, at 12:00p CT through Friday, July 2, 2021, at 5:00p CT.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Submitting a video via Twitter by direct messaging the @ESPNMilwaukee account, commenting on @ESPNMilwaukee's post, or create a post of their own tagging @ESPNMilwaukee.
 - i. To participate in the Promotion, you may log onto www.twitter.com ("Page") or the Twitter App and, if you do not already "Follow" the account, then you must "Follow" @ESPNMilwaukee on Twitter (<https://twitter.com/ESPNMilwaukee/>) in order to access the Promotion. You must have a valid Twitter account in order to enter and your Tweet Privacy must be set to un-protected. If you do not already have one, you can create a Twitter account at no cost by visiting <http://www.twitter.com>. In order to participate in the Promotion, you must submit a video impersonating a real or fictional golfer. Videos can be officially submitted as detailed above. The best video submission as determined by GKB will receive the Grand Prize. Proof of submission of an entry shall not be deemed proof of receipt by GKB. Use of Twitter as a means of entry will be subject to Twitter's privacy policy and terms of service. 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 years of age or older and who reside in the Greater Milwaukee Area.  - Round of 18 for four (4) including two (2) golf carts
 - Unlimited driving range for the day
 - Takeaway Gift
 - Lunch
 - (2) drink tickets per person
 - Opportunity to win additional prizes during the day of the outing
- b. The Approximate Retail Value ("ARV") of the prize is \$700. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize. The gift certificates will be subject to the terms and conditions as set forth by the issuer of the gift certificate. Winner must be able to attend the 2021 Delzer ESPN Milwaukee Open in order to be eligible to win.

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Submission period will take place beginning at 12:00p CT on Monday, June 21, 2021, and closing at 5:00p CT on Friday, July 2, 2021.
- c. The winner will be notified on Friday, July 2, 2021, following the closing of the submission period. All final winners will be known by 5:00p CT on Friday, July 2, 2021.
- d. Odds of winning a Grand Prize depend on the number of submissions during the submission period, as well as the ability to provide the "best" video submission as determined by GKB.
- e. Qualifiers and the Grand Prize winner need not be present to win.
- f. The winner will be contacted either via direct message or reply from the ESPN Milwaukee account on Twitter. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release by Friday, July 9, 2021, at 5:00p CT or prize will be forfeited and an alternate winner may be selected.
