

2021 ESPN CHICAGO FANTASY FOOTBALL CHAMPIONSHIP DRAFT

OFFICIAL RULES

1. HOW TO ENTER

- a. These rules govern the 2021 ESPN Chicago Fantasy Football Championship 2021 Draft (the "Promotion") being conducted by ESPN Chicago, 190 N State St Suite 700, Chicago, IL 60601 ("GKB") beginning on Saturday, August 21, 2021 at 1pm central standard time and ending on August 21st, 2021 at 3pm central standard time at 115 Bourbon Street, 3359 W 115th St., Merrionette Park, IL, 60803 (the "Location").
- b. To participate in the Promotion, log onto ESPNChicagoFFC.com (the "Website") purchase a \$20 ticket to the live draft event and check the "yes" box to the question: "Do you plan to participate in the live Fantasy Football Draft" on the registration page. Deadline to purchase tickets through the website is 11:59pm CT on Wednesday, August 18, 2021. Tickets will be available for purchase for \$25 by walk-up visitors, space permitting, until 9:00am CT day of event.
 - i. Some complimentary (free tickets will be made available through various station events and on-air giveaways).
- c. Entrants must be 21 years or older to participate.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 or older and who reside in Illinois or Indiana. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

3. ON-SITE DRAFT EVENT

ESPNChicago's Fantasy Football Convention and Championship will consist of up to a maximum of fifty (50) 10-team leagues with each team competing against each other teams within the league for 17 weeks. In order to win the Grand Prize, you must win your league which is defined by winning your league's Playoffs. All league winners will be sorted by most total points scored, the participant with the highest total points scored will be deemed the Grand Prize Winner. The following tie-break procedures will

be instituted, in this order: Overall win-loss record, highest point total from Week 14, coin toss.

- a. The on-site draft is open to the first 500 entrants who officially register by presenting a valid ticket at 115 Bourbon Street (the "Venue"), 3359 W 115th St., Merrionette Park, IL 60803. Participants will be entered into each league through random selection and will be seated into leagues on a first come serve basis starting at 8:00 AM CT.
- b. Entrants ("Owners") participating in the on-site ESPN Chicago Fantasy Football Championship draft will select their team using a "Snake Draft" format (draft 1-10 round one, 10-1 in round two, 1-10 in round three, and continuing that way until all sixteen rounds of the draft are complete). Each team will have 60 seconds to make their selection after the player before them makes their pick. If a team fails to make a draft selection in 60 seconds, they will automatically acquire the next best available player.

Owners can pick players at any position throughout the draft, but must have at least one required starter at each of the nine starting positions (1 quarterback, 2 running backs, 2 wide receivers, 1 Flex position, 1 tight end, 1 kicker and 1 defense/special teams).

- c. Each league is based on full point-per-reception scoring. The league rules and scoring are outlined in Appendix A.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. One (1) Grand Prize will be awarded to the Grand Prize Winner of ESPN Chicago's Fantasy Football Championship to receive total prizes in cash and gifts value up to \$7,500.
- b. Prior to awarding any prize(s), GKB will require the winner(s) of such prize(s) to sign a liability release, which holds harmless GKB and its affiliated entities, promotion sponsors, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns against any and all claims or liability arising directly or indirectly from the prize(s) awarded or participation in the Promotion.
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. The potential Grand Prize Winner will be contacted early January 2021 (or at the end of the Fantasy Football season) by phone to claim their prize. The Grand Prize Winner is the League Champion who accumulated the most points compared to any other League Champions.
- c. Odds of winning a Prize depends upon the number entries received.
- d. Winners need not be present to win.
- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within three (3) business days of winning or prize will be forfeited and an alternate winner may be selected based on greatest overall point accumulation of the League Champions. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.
- b. By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize(s) or prize certificate(s), GKB, in its sole discretion, may require Promotion winner(s) (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless GKB, its subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.

- d. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.
- g. GKB is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
- h.
