

## **“2022 FINISH THE BAR”**

### **OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.  
A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.**

#### Contest Overview:

101.7 The Truth fans can participate in the “Finish the Bar” segment on MKE in the Morning for their chance to win a Gruber Law Offices Prize Pack. Each Tuesday from 7-10am CT beginning March 14, 2021, through May 30, 2023. fans can listen for the announcement of the cue to call during the “Finish the Bar” segment. The correct number caller to get through to the WGKB contest line will have the opportunity to participate in the “Finish the Bar” segment. The producer will begin playing a song so that listeners can hear the lyrics. The producer will stop the song mid-sentence or statement and the caller will have to finish the statement or bar. If the first caller cannot successfully finish the lyric, the producer will immediately move on to the next caller until we have a winner. There will be up to twenty-one (21) prize packs given away during the promotion dates. The ARV of each prize is \$15.00.

#### 1. HOW TO ENTER

- a. These rules govern the “Finish the Bar” promotion (the “Promotion”) during MKE in the morning being conducted by WGKB 101.7 The Truth, 720 E Capitol Drive Milwaukee, WI 53212 (“GKB”) beginning on March 14, 202 at 7:00am CT and ending on May 30, 2023 at 10:00am CT.
- b. To participate in the Promotion, you may enter via the following method(s):
  - Cue to call during local on-air programming.
  - i. To participate in the Promotion, you must listen to WGKB beginning on March 14, 2022 and ending on May 30, 2023 each Tuesday between the hours of 7:00am and 10:00am during the promotion dates for the announcement of the cue to call. The cue to call will be announced during the weekly “Finish the Bar” segment. Upon hearing the cue to call, the designated number caller (as announced by the on-air personality prior to the cue to call) to get through to the GKB contest line at (833) 212-1017 will have the opportunity to participate in the “Finish the Bar” segment. The producer will play a song and then stop the song mid-sentence or bar. The caller will then have to finish the statement or bar. If the caller correctly finishes the bar statement or lyric, they will win a prize pack courtesy of Gruber Law Offices upon confirmation of eligibility. At the time of their call, callers will be required to provide all information requested including but not limited to their full name, email address, shipping address (including zip code), day and evening phone numbers, and date of birth to be eligible to win. In the event that the selected caller is disconnected, the next eligible caller that successfully makes it through on the call-in line and completes their call will be a winner. There is no limit to the number of times a listener may attempt to call

in to win, but a listener may be a winner only once every seven days. There may be up to a total of twenty-one (21) winners selected on-air during the Promotion dates. GKB is not responsible for telephone service outages, delays, busy signals, equipment malfunctions or any other technological difficulties that may prevent an individual from completing his/her telephone call. Due to delays in the GKB online streaming of its broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air contests.

- ii. Show times are subject to change based on breaking news and specialty content at the discretion of GKB. GKB has the right to not notify fans and to not update contest rules or the webpage when such situations occur.

## 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years of age or older and who reside in the Greater Milwaukee Area. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in the Greater Milwaukee Metropolitan Area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

## 3. PRIZES

- a. Twenty one (21) prizes will be awarded in this Promotion. Each prize will consist of a Gruber Law Offices Prize Pack which may include but is not limited to:
  - Gruber T-shirt
  - Gruber Drawstring Bag
  - Hand Sanitizer

The ARV of each prize is \$15.00.

- b. All prizes or prize certificates will be mailed to the winner. Upon confirmation of eligibility, a GKB representative will reach out to the winner via phone or email to share the necessary prize

forms with the winner. To claim the prize, each winner must complete and return the required prize forms to GKB. The winner will forfeit any prize or prize certificate not claimed within thirty (30) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss.

- c. GKB is not responsible for the safe arrival of a prize or prize certificate. There is no substitution, transfer, or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities, or any other expenses. Other restrictions may apply.

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Winners will be selected each Tuesday during the "Finish the Bar" segment between 7:00am CT and 10:00am CT. A representative of GKB will contact each winner within 72 hours of their call.
- c. All final winners will be known by 10:00am CT on May 30, 2023.
- d. Odds of winning a Prize depends upon the number and order of calls received, and the caller's ability to correctly finish the bar or statement.
- e. Fans must listen to WGKB 101.7 The Truth's MKE in the Morning to win. Winners need not be present to win a prize.
- f. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within thirty (30) days of winning or prize will be forfeited. If a potential winner cannot be contacted, fails to sign, and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

#### 5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.
- b. By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without

additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.

- c. Prior to awarding any prize(s) or prize certificate(s), GKB, in its sole discretion, may require Promotion winner(s) (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless GKB, its subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.
- d. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed, or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.
- g. GKB is not responsible for typographical or other errors in the printing, the offering, or the administration of the Promotion or in the announcement of a prize.
