

Welke's Ultimate Valentine's Date Night OFFICIAL RULES

CONTEST OVERVIEW

ESPN Milwaukee fans will have the chance to win the ultimate Valentine's Day prize courtesy of Welke's Milwaukee Florist. Fans must register to win by filling out the online form via the contests page at www.welkesdatenight.com beginning on Monday, February 6, 2023, at 7AM CST and ending on Friday, February 10, 2023, at 5PM CST. There will be one (1) grand prize winner selected at random from the eligible form entries. The winner will win a (1) night stay at the Saint Kate hotel, a \$100 Welke's gift card and a \$200 Mo's, A Place for Steaks gift card. The total ARV of the prize is \$500.

1. HOW TO ENTER

- a. These rules govern Ultimate Valentine's Date-Night-In (the "Promotion") being conducted by 94.5 ESPN, WKTI, 301 W Wisconsin Avenue, Suite 200, Milwaukee, WI 53203 ("GKB") beginning on Monday, February 6, 2023, at 7AM CST and ending on Friday, February 10, 2023, at 5PM CST.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Submit your online entry form at www.welkesdatenight.com
 - i. To participate in the Promotion, you may log onto www.welkesdatenight.com and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth, and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. There will be a total of one (1) winner randomly selected online for this Promotion to win the grand prize upon confirmation of eligibility. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not

received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 years of age or older and who reside in Milwaukee, Ozaukee, Waukesha, or Racine County. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in Milwaukee and the surrounding area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

The total ARV of the prize is \$500. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize. The winner must be at least 21 years of age at the time of their entry into the Promotion in order to be eligible to win the prize.

- b. The grand prize winner must complete any required prize forms to accept the prize by 5pm CST on Thursday, February 16, 2023. If the selected winner does not accept by 5pm CST on Thursday, February 16, 2023, a new winner may be

selected in their place.

- c. A representative of GKB's promotions team will reach out to the selected winner via their provided phone or email address to confirm eligibility and share the necessary prize forms. GKB will coordinate a safe delivery of the prize by Friday, February 17, 2023. The selected winner must be able to receive the delivery by Friday, February 17, 2023, between the hours of 9am and 5pm in order to be eligible to win. Winner must be present and able to show a valid ID to accept the prize.
- d. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. There will be one (1) winner selected at random from the online form at www.welkesdatenight.com to win the prize. GKB's promotions team will contact the winner via their provided phone number or email address by 5PM CST on Monday, February 13, 2023, to share the necessary prize forms and coordinate the delivery of the prize.
- c. Odds of winning the Grand Prize depends upon the number of online entries received, the ability to meet the eligibility requirements, and random selection.
- d. Fans must complete the online entry form and be randomly selected in order to win.
- e. The one (1) winner will be contacted by the phone number or email provided in their submission after they are randomly selected. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release by Thursday, February 16, 2023, at 5PM CST or the prize will be forfeited, and an alternate winner will be selected by random drawing. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
