

## 2024 BUCKS PLAYOFFS VS PACERS TICKET GIVEAWAY

### OFFICIAL RULES

WKTI 94.5 ESPN Milwaukee and The Milwaukee Bucks are giving away (2) tickets to the first home playoff games of the Milwaukee Bucks vs. Indiana Pacers. One pair of tickets will be given away on Friday, April 19, 2024, for the Milwaukee Bucks vs. Indiana Pacers game on Sunday, April 21, 2024, at 6:00PM CST. A second pair of tickets will be given away on Monday, April 22, 2024, for the Milwaukee Bucks vs. Indiana Pacers game on Tuesday, April 23, 2024, at 7:30PM CST. Each pair of tickets will be given away during Jen, Gabe and Chewy airing from 7AM – 9AM CST on Friday, April 19, 2024, and Monday, April 22, 2024. The contest will begin on Friday, April 19, 2024, at 7AM CST and end at 9AM CST on Monday, April 22, 2024. Fans may enter by being the correct caller during 94.5 ESPN Jen, Gabe, and Chewy between 7:00am CST and 9:00am CST on Friday, April 19, 2024, and on Monday, April 22, 2024. There will be a total of two (2) grand prizes in the contest. The total ARV of each Grand Prize is \$315.

#### 1. HOW TO ENTER

- a. These rules govern 2024 Bucks vs. Pacers Ticket Giveaway promotion (the “Promotion”) being conducted by WKTI 94.5 ESPN Milwaukee 301 W Wisconsin Ave, Suite 200, Milwaukee, WI 53203 (“GKB”) beginning on Friday, April 19, 2024, at 7AM CST and ending at 9AM CST on Monday, April 22, 2024.
- b. To participate in the Promotion, you may enter via the following method(s): by listening for the cue to call during Jen, Gabe, and Chewy on 94.5 ESPN from 7:00AM CST to 9:00AM CST on Friday, April 19, 2024, and Monday, April 22, 2024.
  - i. To participate in the Promotion, you must listen to 94.5 ESPN each day beginning on Friday, April 19, 2024, and Monday, April 22, 2024, between the hours of 7:00AM CST and 9:00AM CST each day during the time of the promotion for the announcement of the cue to call. Upon hearing the cue to call, the designated number caller (as announced by the on-air personality prior to the cue to call) to get through to the ESPN Milwaukee contest line at 800-990-3776 will win a grand prize upon confirmation of eligibility. At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the call-in line and completes their call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once. There will be up to a total of (2) winners selected on-air during the

## 2. ELIGIBILITY RESTRICTIONS

Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in the Milwaukee metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

The winner on Monday, April 22, 2024, will receive the following grand prize:

- (2) tickets to see the Milwaukee Bucks vs. the Indiana Pacers on Tuesday, April 23, 2024, starting at 7:30PM CST at the Fiserv Forum.

The Approximate Retail Value (“ARV”) of the prize is \$315. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.
