

## VERIZON FLY AWAY TRIP

### OFFICIAL RULES

***NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.***

#### 1. HOW TO ENTER

- a. These rules govern the Verizon Fly Away Sweepstakes (the “Sweepstakes”) being conducted by Good Karma Broadcasting, LLC dba ESPN Chicago, 190 N State St Suite 700, Chicago, IL 60601 (“GKB” or “Administrator”) beginning on Sunday, September 29, 2024 at 8am central time (“CT”) and ending on Sunday, October 20, 2024 at 10pm CT (“Sweepstakes Period”). This Sweepstakes is sponsored by Verizon Corporate Services Group Inc. (“Sponsor”).
- b. To participate in the Sweepstakes for a chance to win one (1) Grand Prize (defined below), you may enter choosing one (1) of the two (2) methods below:
  - i. Go to select Chicagoland Verizon locations during the Sweepstakes Period and scan the designated QR Code on display, and complete the online entry form, or,
  - ii. Go to [www.espnchicagocontests.com](http://www.espnchicagocontests.com), navigate to the Verizon Fly Away Sweepstakes page;
  - iii. Complete the online entry form where you will be asked to provide personally identifiable information, including first and last name, home telephone number, email address, and date of birth (each an “Entry” and collectively a “Entries”) to be entered into a random drawing as further described below in Section 4 (each individual an “Entrant”); and,
  - iv. Limit one (1) entry per person by one (1) of two (2) methods above.
- c. One (1) grand prize winner, defined below, will be selected from all eligible entries received during the Sweepstakes Period. GKB is not responsible for lost, stolen, mangled, misdirected, postage due, illegible, incomplete or late entries.
- d. Entries can only be made by scanning the QR code at select Verizon retail locations or on the Verizon Fly Away Sweepstakes page on [www.espnchicagocontests.com](http://www.espnchicagocontests.com).

#### 2. ELIGIBILITY RESTRICTIONS

- a. The Sweepstakes is open to all persons who: (i) are 21 years old and over as of September 29, 2024; (ii) are legal residents of Illinois and eligible ZIP codes in Indiana, or Wisconsin as outlined in Exhibit A; (iii) and are not Employees of

Sponsor, GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, The Chicago Bears Football Club, Inc. ("Chicago Bears") and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Sweepstakes is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Any entry submitted by any ineligible person(s) will be void.

- b. Entrants are eligible to win a prize in a promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The Grand Prize Winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

### 3. PRIZES

- a. Up to one (1) grand prize will be awarded in this Sweepstakes.
- b. The "Grand Prize" consists of the following: roundtrip airfare for two (2) people to San Francisco, CA from Chicago, Illinois, a two (2)-night hotel stay and two (2) tickets to see the Chicago Bears play the San Francisco 49ers at Levi's Stadium in Santa Clara, California on Sunday, December 8, 2024. **The Approximate Retail Value ("ARV") of the Grand Prize is \$1,800.** Certain travel restrictions may apply. Travel arrangements must be made through GKB. Grand Prize is subject to availability. If the Grand Prize Winner cannot travel on dates specified by GKB, the Grand Prize Winner may be disqualified and an alternate Grand Prize Winner may be selected in GKB's sole discretion. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and ground transportation to/from the airport and/or to/from the hotel, are the responsibility of the Grand Prize Winner. The Grand Prize Winner and travel companion must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the Grand Prize Winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the Grand Prize Winner's stay. The Grand Prize Winner and travel companion must sign a Publicity, Liability Waiver and Travel Release form prior to traveling. If a selected event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, or for any reason beyond the control of the Sponsor, the Sponsor's sole responsibility

to the Grand Prize Winner will be to award the remaining available portion of the prize and no substitution or compensation will be provided for the unawarded portion of the prize.

- c. Grand Prize fulfillment will be handled via email. The Grand Prize Winner will forfeit any prize or prize certificate not claimed within five (5) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, Grand Prize Winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- d. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Sweepstakes are final.
- b. One (1) Grand Prize Winner will be randomly selected by Monday, October 21, 2024 at 5pm CT.
- c. Odds of being selected as a Grand Prize Winner are dependent on total number of entries received during the Sweepstakes Period.
- d. Grand Prize Winner need not be present to win.
- e. The Grand Prize Winner must execute and return any required affidavit of eligibility and/or liability/publicity release within five (5) days of winning or Grand Prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

#### 5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the Grand Prize Winner. The Grand Prize Winner will be required to complete and submit an IRS Form W-9 with the Grand Prize Winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.

- b. By participating in the Sweepstakes, the Grand Prize Winner agrees to have the Grand Prize Winner's name, voice and likeness used in any advertising or broadcasting material relating to the Sweepstakes without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.

BY ENTERING THIS SWEEPSTAKES, ALL ENTRANTS AGREE TO FOREVER WAIVE, RELEASE, DISCHARGE, AND COVENANT NOT TO SUE GKB, SPONSOR, CHICAGO BEARS, THE NATIONAL FOOTBALL LEAGUE, AS WELL AS EACH RESPECTIVE PARTY'S OWNERS, EMPLOYEES, AGENTS, ATTORNEYS, DIRECTORS, OFFICERS, SHAREHOLDERS, CONTRACTORS, SUCCESSORS, ASSIGNS AND INSURERS (COLLECTIVELY "RELEASED PARTIES") FOR AND FROM ANY AND ALL CLAIMS, DEBTS, LIABILITIES, DEMANDS, OBLIGATIONS, COSTS, FEES, EXPENSES, ACTIONS, CAUSES OF ACTION WHATSOEVER, OF EVERY NATURE, CHARACTER AND DESCRIPTION (COLLECTIVE, "CLAIMS"), KNOWN AND UNKNOWN, INCLUDING, BUT NOT LIMITED TO, ALL THOSE ARISING OUT OF OR IN ANY WAY RELATED TO THIS SWEEPSTAKES; THESE OFFICIAL RULES; ENTRANT'S ENTRY; THE NEGLIGENCE OF ANY OF THE RELEASED PARTIES; THE ACCEPTANCE, POSSESSION, MISUSE OR USE OF ANY PRIZE; AND ANY PARTICIPATION IN THIS SWEEPSTAKES. IN ADDITION, EACH ENTRANT ACKNOWLEDGES AND AGREES THAT THE RELEASED PARTIES ARE NOT RESPONSIBLE FOR ANY COSTS, INJURIES, LOSSES, OR DAMAGES OF ANY KIND ARISING FROM OR IN CONNECTION WITH: (I) INCOMPLETE, LOST, LATE, MISDIRECTED OR ILLEGIBLE ENTRIES OR FOR FAILURE TO RECEIVE ENTRIES DUE TO ANY CAUSE, INCLUDING WITHOUT LIMITATION, HUMAN, TRANSMISSION, OR TECHNICAL PROBLEMS, FAILURES, OR MALFUNCTIONS OF ANY KIND, WHETHER ORIGINATING WITH SENDER OR OTHERWISE, THAT MAY LIMIT AN ENTRANT'S ABILITY TO PARTICIPATE IN THIS SWEEPSTAKES; OR (II) ANY INJURY OR DAMAGE RESULTING FROM PARTICIPATION IN THIS SWEEPSTAKES AND/OR THE USE OR MISUSE OF ANY PRIZE (INCLUDING, WITHOUT LIMITATION, CLAIMS, COSTS, INJURIES, LOSSES AND DAMAGES RELATED TO PERSONAL INJURIES, DEATH, DAMAGE TO, LOSS OR DESTRUCTION OF PROPERTY, OR ANY CLAIMS, COSTS, INJURIES, LOSSES, OR DAMAGES RELATED TO OR BASED ON THE ENTRANT'S RIGHTS OF PUBLICITY OR PRIVACY, OR THE ENTRANT'S CLAIM THAT HE OR SHE HAS SOMEHOW BEEN DEFAMED OR PORTRAYED IN A FALSE LIGHT.)
- d. BY SUBMITTING AN ENTRY, ENTRANT REPRESENTS AND WARRANTS THAT HE OR SHE OWNS AND/OR HAS THE AUTHORITY TO RELEASE THE CLAIMS STATED HEREIN. FURTHER, BY SUBMITTING AN ENTRY OR ACCEPTING ANY PRIZE, ALL ENTRANTS AND GRAND PRIZE WINNER EXPRESSLY AGREE TO AT ALL TIMES DEFEND, HOLD HARMLESS, AND INDEMNIFY THE RELEASED PARTIES FROM AND AGAINST ALL CLAIMS OF ANY KIND OR NATURE WHATSOEVER (INCLUDING REASONABLE

ATTORNEYS' FEES AND DISBURSEMENTS) ARISING OUT OF OR IN ANY WAY RELATED TO THIS SWEEPSTAKES; THESE OFFICIAL RULES; ENTRANT'S ENTRY; THE NEGLIGENCE OF ANY OF THE RELEASED PARTIES; THE ACCEPTANCE, POSSESSION, MISUSE OR USE OF ANY PRIZE; AND ANY PARTICIPATION IN THIS SWEEPSTAKES.

THE NATIONAL FOOTBALL LEAGUE, ITS MEMBER PROFESSIONAL FOOTBALL CLUBS, NFL VENTURES, L.P., NFL PROPERTIES LLC, NFL ENTERPRISES LLC, NFL PRODUCTIONS LLC AND NFL INTERNATIONAL LLC AND EACH OF THEIR RESPECTIVE SUBSIDIARIES, AFFILIATES, SHAREHOLDERS, OFFICERS, DIRECTORS, AGENTS, REPRESENTATIVES AND EMPLOYEES (COLLECTIVELY, THE "NFL ENTITIES") WILL HAVE NO LIABILITY OR RESPONSIBILITY FOR ANY CLAIM ARISING IN CONNECTION WITH PARTICIPATION IN THIS SWEEPSTAKES OR ANY PRIZE AWARDED. THE NFL ENTITIES, OTHER THAN THE CHICAGO BEARS FOOTBALL CLUB, INC., HAVE NOT OFFERED OR SPONSORED THIS SWEEPSTAKES IN ANY WAY.

Prior to awarding any prize(s) or prize certificate(s), GKB, in its sole discretion, may require Sweepstakes winner(s) (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless GKB, Sponsor, and their respective parent, subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Sweepstakes.
- g. If for any reason this Sweepstakes cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Sweepstakes, or if the Sweepstakes is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Sweepstakes. If the Sweepstakes is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- h. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Sweepstakes may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Sweepstakes, GKB reserves the right to disqualify that entrant from entering and/or winning future Sweepstakes and to prosecute and seek damages to the fullest extent permitted by law. Sponsor reserves the right to disqualify any individual from participation in the Sweepstakes if Sponsor concludes, in its sole

discretion, that such person: (i) has attempted to tamper with the entry process or other operation of the Sweepstakes; (ii) has committed fraud or attempted to undermine the legitimate operation of the Sweepstakes; or (iii) has acted toward any Sweepstakes Entity or any other entrant in an unfair, inequitable, annoying, threatening, disrupting or harassing manner.

- i. GKB reserves the right to make changes in the rules of the Sweepstakes, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Sweepstakes and shall not be required to award a substitute prize.
- j. GKB is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
- k.
