

2024 ESPN MILWAUKEE SUMMERFEST TICKETS GIVEAWAY

OFFICIAL RULES

WKTI 94.5 ESPN Milwaukee will be running a cue to call promotion to give away tickets to Summerfest 2023. 94.5 ESPN Milwaukee and Summerfest are giving away (4) General Admission Tickets to Summerfest between Tuesday, June 18, 2024, and Friday, July 5, 2024. Fans may enter by listening to Jen, Gabe, and Chewy from 7am CST to 9am CST, Wilde and Tausch from 9am CST to 12pm CST, Kyle, Brust and Nortman from 2pm CST to 5pm CST, and The Homer Hour from 5pm CST to 6pm CST on 94.5 ESPN Milwaukee and wait for the cue to call on regularly scheduled week day programming between June 18, 2024, and July 5, 2024. Fans may also listen for the cue to call during On the Tee on Tuesdays within the specified date range. There will be a total of twenty-five (25) grand prizes in the contest. The total ARV of the Grand Prize(s) is \$112. See below for the structure of the giveaway by show:

1. HOW TO ENTER

- a. These rules govern the 2024 ESPN Milwaukee Summerfest Ticket Giveaway being conducted by 94.5 ESPN Milwaukee 301 W Wisconsin Ave, Suite 200, Milwaukee, WI 53203 ("GKB") beginning at 7am CST on Tuesday, June 18, 2024, and ending at 6pm CST on Friday, July 5, 2024.
- b. To participate in the Promotion, you may enter via the following method(s):
 - a. Tuning into Jen, Gabe, and Chewy, Wilde and Tausch, Kyle, Brust and Nortman, The Homer Hour or On the Tee between June 18, 2024, and July, 5, 2024.
- i. To participate in the Promotion, you must listen to regularly scheduled local weekday programming on WKTI 94.5 ESPN Milwaukee each day beginning on June 18, 2024, and ending on July 5, 2024, between the hours of 7am CST and 6pm CST each weekday, 7am CST to 7pm CST on Tuesdays, during the promotion for the announcement of the cue to call. Upon hearing the cue to call, the designated number caller (as announced by the on-air personality prior to the cue to call) to get through to the GKB contest line at 1-800-920-3776 will win a

grand prize upon confirmation of eligibility. At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the call-in line and completes their call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once. There will be up to a total of (5) winners selected on-air during the Promotion dates. GKB is not responsible for telephone service outages, delays, busy signals, equipment malfunctions or any other technological difficulties that may prevent an individual from completing his/her telephone call. 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years of age and who reside in Wisconsin. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in the Milwaukee metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.

The Approximate Retail Value (“ARV”) of the prize is \$112. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. - b. All prizes or prize certificates will be sent to the winner via email. The winner will forfeit any prize or prize certificate not claimed by July 5, 2024, at 6pm CST. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- b. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Each winner will be selected by 6pm CST on July 5, 2024.
- c. The final winner will be selected on July 5, 2024 by 6pm CST.
- d. Qualifiers must listen to regularly scheduled local weekday programming on WKTI 94.5 ESPN Milwaukee each day beginning on June 18, 2024, and ending on July 5, 2024, between the hours of 7am CST and 6pm CST each weekday, 7am CST to 7pm CST on Tuesdays, during the promotion for the announcement of the cue to call. Qualifiers and the Grand Prize winner need not be present to win.
- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release by July 5, 2024. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website.
