850 ESPN Cleveland and Timberline Cabins are giving fans the chance to win a 4-night stay at one of Timberline Cabins' eleven (11) Ohio properties with the return of the *Really Big Show*'s Holiday Remix contest. Fans age 21 years or older may register by uploading a 45-second parody song featuring a holiday music tune and lyrics about Cleveland sports and/or *The Really Big Show* beginning 9:00AM EST on Monday, November 25, 2024 and 11:59PM EST on Sunday, December 15th, 2024. There will be a total of one (1) winner selected in the contest. The total ARV of the Grand Prize is \$1,500.00.

1. HOW TO ENTER

- a. These rules govern *The Really Big Show* Holiday Remix 2024 promotion (the "Promotion") being conducted by ESPN Cleveland, 1109 Old River Road, Cleveland, Ohio, 44113 ("GKB") beginning on Monday, November 25th, 2024 at 9:00AM EST and ending Sunday, December 15th at 11:59PM EST. The winner will be announced by 1:00PM EST on Thursday, December 19th, 2024.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Submit your parody song and fill out the registration form online at www.ESPNClevelandContests.com
 - i. To participate in the Promotion, you may log onto www.ESPNClevelandContests.com and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address, and an original parody version of a popular holiday song with lyrics incorporating content from *The Really Big Show* or Cleveland sports in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is

not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB's online submission release in order to submit his or her entry.

- c. Only one internet entry per person and one internet entry per email address is permitted.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 years of age or older and who reside in the state of Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. One (1) prize will be awarded in this Promotion. The prize consists of the following:
 - A four (4) night rental of one Timberline Cabins property.

The Approximate Retail Value ("ARV") of the prize is \$1,500. The Prize covers only the cost of property rental. Additional costs may apply at the discretion of Timberline Cabins. Prize must be utilized prior to December 31, 2025. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize

- b. All prizes or prize certificates may be picked up at the office of GKB at the address below or will be coordinated by the GKB team. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate
- b. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. The Grand Prize winner will be selected by Thursday, December 19th, 2024, by 1PM ET. An ESPN Cleveland representative will contact the winner after being announced as the winner to discuss the next steps to get the winner their prize.
- c. Participants will submit a parody song with a popular holiday tune and lyrics involving content from *The Really Big Show* and/or Cleveland sports in the online entry form.
 - Participants will have from Monday, November 25th to Sunday, December 15th to upload their parody song and fill out the online entry form online at www.ESPNclevelandcontests.com
 - All parody songs must be 45 seconds in length or less. If a submission exceeds 45 seconds, only the first 45 seconds of the submission will be considered during the judging process.
 - All parody songs must focus on some aspect of *The Really Big Show* or Cleveland sports.
 - During the promotion, the members of *The Really Big Show* will begin listening to each entry and will determine the top-5 parody entries. Note that all entries will be listened to, but all may not be played on-air. The top-5 entries will be determined by Thursday, December 19th.
 - During The Really Big Show on Thursday, December 19th, a panel of three judges will listen to and judge each of the top-5 entries.
 - Each judge will rate each top-5 entry on a scale from 1-10 in three categories: creativity, production value, and memorability.
 - The entry that has highest cumulative score amongst the judges will be deemed the Grand Prize winner of this Promotion.
 - In the event of a tie, there will be a fourth judge designated as the tie breaking judge. They will rate each of the tied entries on a scale from 1-10 in three categories: creativity, production value, and memorability.
 - The entry among those that are tied that receives the highest cumulative score amongst the three categories, as rated by the tie breaking judge, will be

deemed the Grand Prize winner of this Promotion.

- d. Grand Prize winner need not listen to win.
- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.
- b. By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.

- d. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f.
