CONTEST

101.7 The Truth will execute a contest to give away (1) Chula Vista Getaway package each week during Women’s History Month. The giveaway will take place on “Truth Be Told with DT and Telly” from 7 AM CST – 9AM CST the first two (2) weeks of March and on “Nothin’ But The Truth with Mel” from 12P CST - 1P CST the final two (2) weeks of March. Once per week during March 2024 on 101.7 The Truth, the voice of a famous black woman in history will be played over the air after which a cue for fans to call in to guess who’s voice it is. If the caller guesses correctly, then they are the winner of the Women’s History Month Game. If the caller guesses wrong, the show host will move on to the next caller in order to guess the correct answer of the Women’s History Month Game.

The promotion will run beginning Wednesday, March 6, 2024, and continue until Friday, March 29, 2024. This contest will run during “Truth Be Told with DT and Telly” from 7 AM CST – 9AM CST the first two (2) weeks of March and on “Nothin’ But The Truth with Mel” from 12P CST - 1P CST the final two (2) weeks of March. The host will announce a cue to call during their show following the recording of the voice of a famous black woman in history. The caller to get through to the contest line and correctly answer will win one (1) Chula Vista Wisconsin Dells Prize Package. One (1) Chula Vista Wisconsin Dells Prize Package consists of:

- 1 Night Stay at the Chula Vista*
- 4 Water Park Passes*
- \$25 Dining Voucher for Kaminski’s Chop House, Kilbourn City Grill or The Tavern Restaurant*

There may be (1) winner each week during the promotion. The ARV of the prize is \$355.00.

1. HOW TO ENTER

- a. These rules govern the “Women’s History Month Game” (the “Promotion”) being conducted by WGKB 101.7 The Truth, 301 W Wisconsin Ave, Suite 200, Milwaukee, WI 53203 (“GKB”) beginning on Wednesday, March 6, 2024, and ending on Friday, March 29, 2024, during “Truth Be Told with DT and Telly” from 7 AM CST – 9AM CST the first two (2) weeks of March and on “Nothin’ But The Truth with Mel” from 12P CST - 1P CST the final two (2) weeks of March.

- b. To participate in the Promotion, you may enter via the following method(s):
- Cue to call during on air local programming.
- c. To participate in the Promotion, you must listen to WGKB 101.7 The Truth each Friday beginning on Wednesday, March 6, 2024, and ending on Friday, March 29, 2024, during “Truth Be Told with DT and Telly” from 7 AM CST – 9AM CST the first two (2) weeks of March and during “Nothin’ But The Truth with Mel” from 12P CST - 1P CST the final two (2) weeks of March, and wait for an announcement, from the host, of the cue to call following the playing of a recording of a famous black woman in history. Upon hearing the cue to call, the first caller (announced by the on-air personality prior to the cue to call) to get through to the GKB contest line at 833-212-1017 will have the opportunity to name the correct answer to the owner of the voice played on air. If the caller does not guess the correct number, the appropriate show host has the right to continue selecting a new cue to call as designated until the right answer has been guessed correctly. At the time of their call if answered correctly, the caller will be required to provide all information requested, including their full name, complete address (including zip code), day and evening phone numbers, and date of birth in order to be eligible to win. In the event that the selected caller is disconnected or is found to be ineligible, the caller will forfeit the prize and there would be no prize distributed for that designated day. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once. There will be up to a total of (4) winners selected during the Promotion dates. Each winner will get one (1) Chula Vista Wisconsin Dells Prize Package consisting of: one (1) Night Stay at the Chula Vista, four (4) Water Park Passes, one (1) \$25 Dining Voucher for Kaminski’s Chop House, Kilbourn City Grill or The Tavern Restaurant (**All Vouchers Expire 5/24/24*). GKB is not responsible for telephone service outages, delays, busy signals, equipment malfunctions, or any other technological difficulties that may prevent an individual from completing his/her telephone call. Due to delays in the GKB online streaming of its broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air contests.
- i. Show times are subject to change based on breaking news and specialty content at the discretion of GKB. GKB reserves the right to not notify fans and to not update contest rules or the webpage when such situations occur.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years of age and who reside in the Greater Milwaukee Area. Employees of GKB, its subsidiary and affiliated entities, GKB’s advertising and promotional agencies, its participating sponsors, [other radio stations in the Milwaukee metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are

ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. All prizes will be electronically delivered to the winner via email. The winner will forfeit any prize or prize certificate not claimed within (10) days of winning the prize. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate. Some prizes may be picked up at will call at the prize location and GKB will inform listeners of the ones that apply.
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are

expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION & NOTIFICATION

- a. Decisions of GKB Management with respect to the Promotion are final.

- b. Each weekly winner will be known by the end of the day every Friday in March by 6:00pm CST. A representative of GKB will contact each winner by at the latest the following Monday after each time the contest is run.

- c. The odds of winning a Qualifying Prize depend upon the number and order of calls received. Odds of winning the prize also depend on the ability of the caller to correctly identify the voice of the famous black woman in history whose voice is played over air.

- d. Qualifiers must listen to WGKB 101.7 The Truth during “Truth Be Told with DT and Telly” from 7 AM CST – 9AM CST the first two (2) weeks of March and on “Nothin’ But The Truth with Mel” from 12P CST - 1P CST the final two (2) weeks of March.

- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited. An alternate winner will not be selected by random. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

- a. Payments of all federal, state, and local taxes are solely the responsibility of the winner. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement.
