

2025 THANALYSIS X CANDY FUNHOUSE GIVEAWAY

OFFICIAL RULES

Fans may enter by following *Thanalysis Show* Instagram Page (@Thanalysisshow) and commenting a candy name on promotional post between Thursday, February 20, 2025, and Wednesday, February 26, 2025. There will be a total of 2 qualifying prizes and 1 grand prize in the contest. The total ARV of the Grand Prize(s) is/are \$300.

1. HOW TO ENTER

- a. - b. To participate in the Promotion, you may enter via the following method(s):
 - a. In order to enter contest, entrants must “Follow” the page and comment your favorite candy under promotional post.
 - i. To participate in the Promotion, you may visit Thanalysis Show (“Page”). If you do not already “Follow” the Page, you must “Follow” the Page and comment a candy name under the post in order to access the Promotion. You must have a valid Instagram account in order to enter. If you do not already have one, you can create a Instagram account at no cost by visiting <http://www.instagram.com>. Limit one (1) entry per eligible person during the Entry Period regardless if entrant has more than one email address or Instagram account. Multiple participants are not permitted to share the same email address or Instagram account. Entries submitted may not be acknowledged or returned. 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years or older and who reside in the United States/Canada/Greece. - b. Wednesday, February 26, 2025, at 3:00 PM/CST three (3) winners will be selected by random selection from promotional Instagram post. Winners selected must; “follow” @Thanalysisshow [Page] and comment a candy name on ‘Candy Funhouse Giveaway’ post.
- c. Winners will be selected and announced on Thanalysis Show [Instagram Page], on Wednesday, February 26, 2025.
- d. Odds of winning a Qualifying Prize depend upon the number of comments on promotional posts.
- e. Qualifiers must listen to Thanalysis Show to win. Qualifiers and the Grand Prize winner need not be present to win.
- f. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited, and an alternate winner may be selected by random selection.
