

2026 SUPERB OWL SQUARES

OFFICIAL RULES

94.5 ESPN Milwaukee are giving away a contest to giveaway ten (10) qualifying prizes and one (1) grand prize of one (1) Virtual Interior Design Service, one (1) Home Improvement Store gift card, one (1) "*Got Your Legends*" book by Mike Greenberg and Hembo, one (1) Jen, Gabe, and Chewy hoodie. In order to win, fans must listen to Jen, Gabe & Chewy from 7a CT to 9a CT each day beginning Monday, February 3, 2026, through Friday, February 6, 2026, for the announcement of the cue to call. Fans must then correctly answer the daily trivia question as explained by the show's host. If the caller is incorrect, then another caller will be taken and have the opportunity to guess. If a caller answers the question correctly, they will win a qualifying prize. The qualifying prize is an opportunity to participate in a "Superb Owl Squares" game as described below. The grand prize winner will be determined by the final score of the game between the New England and the Seattle football game on Sunday, February 8, 2026. The grand prize will consist of one (1) virtual interior design service. ARV of the grand prize is \$650.

HOW TO ENTER

- a. These rules govern the 2026 SUPERB OWL SQUARES promotion (the "Promotion") being conducted by WKTI 94.5 ESPN Milwaukee, 301 W Wisconsin Ave, Suite 200, Milwaukee, WI 53203 ("GKB") beginning at 7:00 AM/CST on Monday, February 2, 2026, and ending at 9:00 AM/CST on Friday, February 6, 2026.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Cue to Call during on-air local programming. Promotion will be run during Jen, Gabe & Chewy from 7:00 AM/CST to 9:00 AM/CST each weekday from Monday, February 2, 2026, through Friday, February 6, 2026.
- i. To participate in the Promotion, you must listen to WKTI 94.5 ESPN Milwaukee each day beginning on Monday, February 2, 2026, and ending on

Friday, February 6, 2026, between the hours of 7:00 AM/CST to 9:00 AM/CST each weekdays during the promotion dates for the announcement of the cue to call. Upon hearing the cue to call, the designated number caller (as announced by the on-air personality prior to the cue to call) to get through to the GKB contest line at (800)-990-3776 will win a qualifying prize upon confirmation of eligibility. The caller will be asked a trivia question. If the caller guesses incorrectly, then a new caller will get through to the GKB contest line and have the opportunity to answer. This will continue until a caller guesses the trivia question correctly. Once a caller correctly answers the trivia question, they will get the opportunity to participate in a game of "Super Bowl Squares". For this game, there will be a 10x10 grid with each axis

- i. numbered from 0-9. One axis will be labeled "New England" and the other will be labeled "Seattle". Each square pertains to a potential final scoring outcome in the game between the New England and the Seattle football game on Sunday, February 8, 2026. The numbers on each axis represent the potential last number of each team's point total at the end of the game. Each caller to correctly answer the trivia question will have ten (10) squares randomly selected for them from the grid. Once a square is selected, it cannot be selected again. Each qualifying winner will be given ten (10) squares from the remaining options at the time of their call. The qualifier that has the square that accurately reflects the last number of each team's final point total will win a grand prize upon confirmation of eligibility. At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the call-in line and completes their call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once. There will be up to a total of ten (10) qualifying winners selected on-air during the Promotion dates and one (1) grand prize winner. - Qualifying winners will be selected on-air during Jen, Gabe & Chewy each weekday of the promotion dates between 7:00 AM/CST to 9:00 AM/CST. The grand prize winner will be identified as the qualifier that was given the square that accurately reflected the final score of the game between the New England Football Team and the Seattle Football Team on Sunday, February 8, 2026.
- All qualifying winners will be known by Friday, February 6, 2027, at 9:00 AM/CST. The grand prize winner will be known following the conclusion of the game between the New England Football Team and the Seattle Football Team on Sunday, February 8, 2026.
- Odds of winning a qualifying prize depends upon the number and order of calls received and the caller’s ability to correctly answer the trivia question. Odds of winning the grand prize depends on the caller’s ability to win a qualifying prize and random selection of the square that accurately reflects the final score.
