

ESPN Cleveland's 3rd Annual RBS Pitmaster Contest Presented by Cedar Point

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. HOW TO ENTER

- a. These rules govern the "ESPN Cleveland 2nd Annual RBS Pitmaster Contest Presented by Cedar Point" promotion (the "Promotion") being conducted by ESPN Cleveland & Good Karma Broadcasting ("GKB") beginning on April 23, 2018 at 9:00am ET and ending on May 11, 2018 at 1pm ET.
- b. To participate in the Promotion, you may enter via the following method(s): Go to espnlevelandcontests.com and register on the forms page by typing in your name, phone number, and email. You may enter your personal information only one time into the forms page on espnlevelandcontests.com. Entrants will be required to submit a 200-word (or less) paragraph explaining why they deserve one of the nine (9) spots in the cookoff. ESPN Cleveland will randomly pick 9 people from the list to participate in the ESPN Cleveland 3rd Annual RBS Pitmaster Contest Presented by Cedar Point on June 21st, 2018 at Cedar Point. If you are one of the 9 winners, you are automatically entered into the competition for the grand prize. One winner from those participants will be selected as the overall contest winner on June 21st, 2018.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years and over and who reside in the state of Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the Cleveland metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. You cannot get compensated for your cooking skills to participate in this Promotion. Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every thirty (30) days and only once every six (6) months if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.

- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. The 9 participants randomly selected for the “contest” will receive a 1-day pass for 4 people (4 total, including participant) to Cedar Point on Thursday, June 21, 2018.
- b. There will be (1) grand prize awarded in this Promotion. The prize consists of the following:
 - (4) Four season passes to Cedar Point for the 2018 season (provided by Cedar Point), (1) one grand prize Pitmaster trophy, and a \$150 gift card to Heat Exchange.

The Approximate Retail Value (“ARV”) of the grand prize is \$750.

- c. The second-place winner will receive a \$75 gift card to Heat Exchange.
- d. The third-place winner will receive a \$50 gift card to Heat Exchange.
- f. The fourth through tenth place winners will receive a \$25 gift card to Heat Exchange.
- g. One online submission will be rewarded a position as a judge for the competition. This person will be selected at random from completed entries. This person will receive entry to the park valued at \$40+.
- b. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. The top 9 participants for the “contest” will be selected during the week of May 14, 2018. The 10th contestant will be the winner of the 2017 RBS Pitmaster. The overall winner of the “contest” will be selected on Thursday, June 21st, 2018, between 12:30pm ET and 1pm ET.
- c. Odds of being one of the 10 total participants selected depends upon how many people sign up on espnlevelandcontests.com. Odds of winning the grand prize are 1 out of 10.
- d. Winner will be notified on-site at Cedar Point between 12:30pm ET and 1pm ET on Thursday,

June 21st, 2018 to confirm eligibility. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited. If winner has not confirmed eligibility by Thursday, June 21st, 2018 at 1pm, an alternate winner will be selected. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.
- b. By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize(s) or prize certificate(s), GKB, in its sole discretion, may require Promotion winner(s) (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless GKB, its subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.
- d. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in

connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.

- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.
- g. GKB is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
- h. If there is a tie, we will do a random drawing of the names of the contestants that tie to decide a final winner.
- i. Winners can get access to Cedar Point to drop off their grilles/smokers at a TBD time on Wednesday evening (June 20, 2018).
- j. Contestants must bring their own grille/smoker and meat. The meat must be 1 slab of pork spare ribs. Contestants can start grilling/smoking as early as 5am on Thursday, June 21, 2018. The meat must be done by 12pm on Thursday, June 21, 2018 to be judged.
- k.
