1. HOW TO ENTER

- a. i. To participate in the promotion, you must listen to local programming as detailed above on WGKB 101.7 The Truth each weekday, beginning on Monday, April 4, 2022, and ending on Friday, June 30, 2023, during the "Promotion Dates" for the announcement of the cue to call. Upon hearing the cue to call, the caller number announced by the host who gets through to the WGKB 101.7 The Truth contest line at 833.212.1017 will be entered in a drawing for a chance to win a Gruber Law Offices Prize Pack given away every week, and the Gruber Law Offices One Call That's All \$5,000 Quarterly Cash Giveaway. 101.7 The Truth will announce the Gruber Law Offices One Call That's All \$5,000 Quarterly Cash Giveaway on the dates and shows listed above. During the "Promotion Dates" every weekday, Monday through Friday, the cue to call will occur on a different local show, as detailed above. At the time of their call, callers will be required to provide all information requested, including their full name, complete address (including zip code), day and evening phone numbers, and date of birth in order to be eligible to win. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the call-in line and completes their call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may only be entered to win once. 2. ELIGIBILITY RESTRICTIONS

- a. The promotion is open to all persons who are 18 years of age or above and reside in the Greater Milwaukee Area. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in the Greater Milwaukee metropolitan area and the members of their immediate families (spouse, parents, siblings, or

- b. There will be 315 qualifying fans entered for a chance to win the Gruber Law Offices Prize Pack and the Gruber Law Offices \$5,000 Cash Giveaway. There will be sixty-four (64) winners of the Gruber Law Offices Prize Pack every week during the "Promotion Dates". There will be one (1) winner randomly selected every quarter during the "Promotion Dates", for a total of five (5) Gruber Law Office \$5,000 Quarterly Cash Giveaway winners.
