

710 LOS ANGELES RAMS HOME OPENER GIVEAWAY

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. HOW TO ENTER

- a. These rules govern the 710 LOS ANGELES RAMS HOME OPENER GIVEAWAY promotion (the "Promotion") being conducted by Good Karma Broadcasting, dba ESPN Los Angeles, 800 W. Olympic Blvd Suite 200, Los Angeles CA 90015 ("GKB") beginning on Friday, May 6th, 2022, at 10 AM PST and ending on Wednesday, May 11th, 2022, at 10 AM PST.
- b. To participate in the Promotion, you may enter via the following method(s): Visit the contest page on www.goodkarmabrands.com/espn-los-angeles-contests/.com and complete the online entry form during the Promotion Period and confirm eligibility requirements.
 - i. To participate in the Promotion, you may log onto www.goodkarmabrands.com/espn-los-angeles-contests/.com and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth, a valid email address in the online entry form and submit your prediction for the Los Angeles Rams Home Opener opponent for the 2022 regular season. Only one internet entry per nominee and one (1) internet entry per email address is permitted. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB's online submission release in order to submit his or her entry.
- c. Only one (1) internet entry per fan is permitted.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 or older and who reside in the United States. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the

members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. Current or former employees, family members, agents, successors, or assignees of the client or any promotional agency involved with this promotion shall be INELIGIBLE to participate. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.

- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. Up to (1) Grand prize will be awarded in this Promotion. Prize consists of the following:
 - a. (2) tickets to the Los Angeles Rams home opener at SoFi Stadium on Thursday, September 8th, 2022.

The total ARV of the prize is \$300.00. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize. The winner must be at least 18 years of age at the time of their entry into the Promotion in order to be eligible to win the prize.

- b. The grand prize winner must complete any required prize forms to accept the prize by 5 PM PST on Friday, May 20th, 2022. If the selected winner does not accept by the previously stated deadline, a new winner will be selected in their place.
- c. A representative of GKB's team will reach out to the selected winner via their provided phone or email address to confirm eligibility and share the necessary prize forms. The selected winner must be able to attend the event on Thursday, September 8th, 2022, in order to be eligible to win. Winner must be present and able to show a valid ID to accept the prize.
- d. There is no substitution, transfer, or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The

prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities, or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. The Grand Prize winner will be randomly selected from all the correct predictions, by Monday, May 16, 2022, at 12 PM PST.
- c. Odds of being a winner depends upon the number of entries received.
- d. Grand Prize winner does not have to listen to 710 ESPN to win.
- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited, and an alternate winner may be selected by the same method as above. If a potential winner cannot be contacted, fails to sign, and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
