Upon hearing the cue to call, the designated number caller (as announced by the on-air personality prior to the cue to call) number 7 to get through to the GKB contest line at (877)710-8773 will win a chance to play in the Wiffle Ball Bash at the 2023 ESPN LA All-Star Friday Night where the champion wins a four-pack of baseball tickets upon confirmation of eligibility. - c. Friday, July 14, 2023 at approximately 6:45 PM PT

- e. Whoever has the most homeruns during the wiffleball bash will be the winner of the grand prize. In the case of a tie, the person who hit the furthest ball will be the winner.

- g.
