

# The ArchnemeSWISS Giveaway

### CONTEST OVERVIEW

There will be a total of two (2) grand prize winners selected at random from the eligible form entries. There will be one (1) Milwaukee-area winner and (1) Chicago-area winner randomly selected. The Chicago-area winner will win a Chicago Bears themed prize pack courtesy of Mars Cheese Castle. The Milwaukee-area winner will win a Green Bay Packers themed prize pack courtesy of Mars Cheese Castle. The ARV of each prize is \$180.00.

### 1. HOW TO ENTER

- a.   - i. To participate in the Promotion, you may log onto [www.ESPNWisconsinContests.com](http://www.ESPNWisconsinContests.com) or [www.ESPNChicagoContests.com](http://www.ESPNChicagoContests.com) and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. There will be a total of two (2) winners randomly selected online for this Promotion to win the grand prize upon confirmation of eligibility. There will be one (1) Milwaukee-area winner and (1) Chicago-area winner selected. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized

account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. ## 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years or older and who reside in the Greater Milwaukee area or the Greater Chicagoland area. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in Milwaukee and the surrounding area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. There will be two (2) winners selected at random from the online form at either [www.ESPNWisconsinContests.com](http://www.ESPNWisconsinContests.com) or [www.ESPNChicagoContests.com](http://www.ESPNChicagoContests.com) to win a prize. GKB's promotions team will contact the winner via their provided email address by 5PM CST on Monday, November 30, 2020 to share the necessary prize forms.
- c. Odds of winning a Prize depends upon the number of online entries received, the ability to meet the eligibility requirements, and random selection.
