CONTEST OVERVIEW

ESPN Milwaukee fans will have the chance to win an Ariens Deluxe 24 Snow Blower. Fans must register to win by filling out the online form via the contests page at www.SnowDayDameday.com on any one of the three Promotional Dates: 11/28/21, 12/12/21, 12/25/21. There will be one (1) grand prize winner selected at random from the eligible form entries. The winner will win an Ariens Deluxe 24 Snow Blower. The total ARV of the prize is \$1,566.00.

1. HOW TO ENTER

- a. These rules govern Ariens Snow Day Gameday Giveaway (the “Promotion”) being conducted by 94.5 ESPN, WKTI, 720 E Capitol Dr, Milwaukee, WI 53212 (“GKB”) on Sunday, November 28, 2021 from 12AM CST – 11:59PM CST, Sunday, December 12, 2021 from 12AM CST – 11:59PM CST, and Saturday, December 25, 2021 from 12AM CST – 11:59PM CST.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Submit your online entry form at www.SnowDayDameday.com on any one of the (3) Promotional Dates.
- i. To participate in the Promotion, you may log onto www.SnowDayDameday.com and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth, and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted per Promotional Date. Fans can submit up to (3) total entries, (1) on each of the (3) Promotional Dates between 12AM CST – 11:59PM CST: 11/28/21, 12/12/21, 12/25/21. There will be a total of one (1) winner randomly selected online for this Promotion to win the grand prize upon confirmation of eligibility. Entries will carry over between Promotional Dates. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain

associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years of age or older and who reside in the Greater Milwaukee, Madison, or Green Bay areas. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in Milwaukee and the surrounding area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.

3. PRIZES

- a. One (1) grand prize will be awarded in this Promotion. The prize will consist of an Ariens Deluxe 24 Snow Blower. The total ARV of the prize is \$1,566.00. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize. The winner must be at least 18 years of age at the time of their entry into the Promotion in order to be eligible to win the prize.
- b. The grand prize winner must complete any required prize forms to accept the prize by 12pm CST on Friday, January 7, 2022. If the selected winner does not

accept by 12pm CST on Friday, January 7, 2022, a new winner may be randomly selected in their place from the remaining eligible form entries.

- c. A representative of GKB's promotions team will reach out to the selected winner via their provided phone or email address to confirm eligibility and share the necessary prize forms including but not limited to an Accepting Prize Form and a W9. Upon confirmation of eligibility, GKB will share the grand prize winner's contact information with Ariens, who will coordinate the safe exchange of the prize

The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. There will be one (1) winner selected at random from the online form at www.SnowDayDameday.com to win the prize. GKB's promotions team will contact the winner via their provided phone number or email address by 5PM CST on Monday, January 3, 2022 to share the necessary prize forms.
- c. Odds of winning the Grand Prize depends upon the number of online entries received, the ability to meet the eligibility requirements, and random selection.
- d. Fans must complete the online entry form on one of the Promotional Dates and be randomly selected in order to win.
- e. The one (1) grand prize winner will be contacted by the provided phone number after they are randomly selected. The grand prize winner must execute and return any required affidavit of eligibility and/or liability/publicity release by 12PM CST on Friday, January 7, 2022 or the prize will be forfeited, and an alternate winner will be selected by random drawing. - e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
