CONTEST OVERVIEW

ESPN Milwaukee fans will have the chance to win a basketball arcade game courtesy of BODYARMOR. Fans must register to win by filling out the online form via the contests page at www.BodyArmorBuzzerBeater.com. There will be two entry periods during this promotion with the first beginning on Monday, March 15, 2021 at 7AM CST through Wednesday, March 24, 2021 at 11:59PM CST, and the second beginning Saturday, March 27, 2021 at 7AM CST through Saturday, April 3, 2021 at 11:59PM CST. There will be two (2) grand prize winners selected at random from the eligible form entries. Each winner will win a basketball arcade game. The total ARV of each prize is \$775.00.

1. HOW TO ENTER

- a. These rules govern BODYARMOR Buzzer Beater (the "Promotion") being conducted by 94.5 ESPN, WKTJ, 720 E Capitol Dr, Milwaukee, WI 53212 ("GKB") beginning on Monday, March 15, 2021 at 7AM CST through Wednesday, March 24, 2021 at 11:59PM CST, and Saturday, March 27, 2021 at 7AM CST through Saturday, April 3, 2021 at 11:59PM CST
- b. To participate in the Promotion, you may enter via the following method(s):
 - Submit your online entry form at www.BodyArmorBuzzerBeater.com
- i. To participate in the Promotion, you may log onto www.BodyArmorBuzzerBeater.com and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth, and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. There will be a total of two (2) winners randomly selected online for this Promotion to win a grand prize upon confirmation of eligibility. The first grand prize winner will be selected on Thursday, March 25, 2021 following the first entry period (3/15/21 – 3/24/21). The second grand prize winner will be selected on Monday, April 5, 2021 following the second entry period (3/27/21 – 4/3/21). All eligible form entries that were not randomly selected to be the first grand prize winner on Thursday, March 25, 2021 will carry over to the second entry period and be eligible to be randomly selected on Monday, April 5, 2021. A winner may only

win a prize once during this promotion. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years of age or older and who reside in the Greater Milwaukee Area. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in the Greater Milwaukee Area and the surrounding area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

3. PRIZES

- a. Two (2) grand prizes will be awarded in this Promotion. Each prize will consist of a basketball arcade game. The total ARV of each prize is \$775.00. One (1) winner will be randomly selected from the eligible form entries on Thursday, March 25, 2021. One (1) winner will then be randomly selected from all remaining eligible form entries on Monday, April 5, 2021. Each winner will be

solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize. Each winner must be at least 18 years of age at the time of their entry into the Promotion in order to be eligible to win the prize.

- b. Upon being selected, GKB's promotions team will contact the potential winner via the phone or email address provided on their online form submission to share the necessary prize forms and confirm eligibility. All winners will be required to complete an Accepting Prize Form as well as a W9 Form in order to claim their prize. Each grand prize winner must complete and return any required prize forms to GKB to accept the prize within ten (10) days of being selected. If the selected winner does not accept the prize within ten (10) days, a new winner may be selected in their place from the remaining eligible entries.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. There will be two (2) winners selected at random from the eligible form entries at www.BodyArmorBuzzerBeater.com to win the prize. GKB's promotions team will contact each winner via their provided phone number or email address by 5PM CST on their respective selection dates as detailed in these contest rules to share the necessary prize forms and confirm eligibility.
- c. Odds of winning the Grand Prize depends upon the number of online entries received, the ability to meet the eligibility requirements, and random selection.
- d. Fans must complete the online entry form and be randomly selected in order to win. All final winners will be known by Monday, April 5, 2021 at 5PM CST.
- e. The winner will be contacted by the phone number or email provided in their submission after they are randomly selected. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of their selection or the prize will be forfeited, and an alternate winner may be selected by random drawing from the remaining eligible entries. If a

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a
