  - i. To participate in the Promotion, fans who arrive at the Mandy Awards II, The Commerce Casino & Hotel, 6131 Telegraph Road, Commerce, CA 90040 (the "Event") on Saturday, June 10<sup>th</sup>, 2023, and visit the check-in table between 4:30 PM PST and 8:00 PM PST with a valid Event ticket will be given name badges. Two (2) of the badges, selected at random, will have the Barbecues Galore logo displayed. The two (2) fans with these badges will be named the Qualifying winners. Qualifying winners will then be assigned a team in the survey-style game during the Event. The Grand Prize winner will be the corresponding Qualifying winner whose team wins the survey-style game. GKB is not responsible for lost, stolen, mangled, misdirected, postage due, illegible, incomplete or late entries.
- c. Each fan's name badge, received upon check-in to the Event, will be their only entry.

## 2. ELIGIBILITY RESTRICTIONS

## 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Qualifying winners will be determined during the check-in process ahead of the Event on Saturday, June 10<sup>th</sup>, 2023.
- c. Grand Prize winner will be determined following the survey-style game conducted on stage during the Event on Saturday, June 10<sup>th</sup>, 2023.
- d. Odds of winning a Qualifying Prize depends upon the number of attendees present at the Event. Odds of a Qualifier winning the Grand Prize are 1 in 2.

- e. Once Qualifiers are determined by finding the two fans with the Barbecues Galore logo on their name badges, each Qualifier will be assigned a team for the survey-style game (Team Momo or Team Mychal). The survey-style game will be conducted as follows:
  - i. Two teams will be competing in this game.
  - ii. One player from each team approaches the center, with one hand behind their backs and the other flat on the table, ready to buzz in.
  - iii. The question is read once and stops at the first buzz in. The question may be re-read after the first player to buzz in makes their guess.
  - iv. If the first player who buzzed in reveals an answer that isn't the top answer, then the other player has a chance to guess an answer.
  - v. First to buzz in and provide an answer that is revealed highest ranking on the board can choose for their team to pass, or play.
  - vi. If neither player is able to make any correct guesses during the face-off, then play goes to the second player of the team of the first player who buzzed in and continues to alternate between teams until a correct answer is given.
  - vii. After a team has chosen to pass or play, the playing team must guess the remaining answers on the board.
  - viii. Players on the team answer one at a time, with no help from their other teammates. If a player incorrectly guesses or doesn't provide a guess in time, the team receives a strike.
  - ix. When a team reaches (3) strikes, the opposing team has a chance to steal the board. The opposing team can work together to quickly come up with an answer.
  - x. If the opposing team reveals one of the remaining answers on the board, the opposing team steals all the revealed points for that round.
  - xi. If the opposing team is unable to reveal an answer on the board, the original playing team keeps the points they've earned and the round is over. The remaining answers are revealed.
  - xii. The team with the leading score after four rounds wins the game.
  - xiii. If the teams are tied after four rounds, the tiebreaker is played to a faceoff round
    - One player from each team approaches the center, with one hand behind their backs and the other flat on the table, ready to buzz in.
    - The question is read once and stops at the first buzz in. The question may be re-read after the first player to buzz in makes their guess.
    - If the first player who buzzed in reveals an answer that isn't number 1, then the other player has a chance to guess an answer.
    - The player with the highest-scoring guess wins the face-off round and game
- f. Once the survey-style game has ended, the winner of that game will determine which of the Qualifiers wins the Grand Prize.

- g. Qualifiers and the Grand Prize winner must be present during the Event to win.
- h. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited.
