

ESPN New York Beach Bash Register-To-Win Giveaways

OFFICIAL RULES

Fans may enter by registering to win in person between 2 PM EST and 8 PM EST on Friday, July 1st, 2022, at the ESPN New York Beach Bash, located at Bar Anticipation (703 16th Avenue, Lake Como, NJ). There will be a total of (17) prizes in the contest. The total ARV of the Grand Prize(s) vary based on which prize is won. All prizes and corresponding approximate retail values can be found in the Prizes section below.

1. HOW TO ENTER

- a. These rules govern the ESPN New York Beach Bash Register-To-Win Giveaways promotion (the "Promotion") being conducted by Good Karma Broadcasting, LLC, ESPN New York, 880 3rd Ave, 12th Floor, New York, New York 10022 ("GKB") on Friday, July 1st, 2022, beginning at 2 PM EST and ending at 8 PM EST.
- b. To participate in the Promotion, you may enter via the following method(s):
 - i. To participate in the Promotion, you may go to Bar Anticipation (703 16th Ave, Lake Como, NJ) on Friday, July 1st, 2022, starting at 2 PM EST and ending at 8 PM EST and complete an official entry form (while supplies last) including first and last name, complete address, city, state, zip code, home telephone number and date of birth, and put the entry form in the registration box. All entries must be received by 8 PM EST. GKB is not responsible for lost, stolen, mangled, misdirected, postage due, illegible, incomplete or late entries.
- c. Only one entry per person per register-to-win box will be eligible. Fans may enter multiple drawings, but may not enter any drawing more than once.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 years of age or older and who reside in the United States of America. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the New York City metropolitan area (NY, NJ, CT, PA) and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.

The Approximate Retail Value (“ARV”) for all prizes are listed immediately above. Any gift card prizes will be subject to the terms and conditions as set forth by the issuer of the gift certificate.

- b. All prizes or prize certificates may either be picked up on site at the end of the event on Friday, July 1st, 2022, or may be delivered via mail or email, depending on the prize won. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning, or the ticket date in the event that the tickets are dated sooner than forty-five (45) days. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. All drawings will be done at 8 PM EST on site at the ESPN New York Beach Bash, at which point a random entry will be drawn at random.
- c. Odds of winning any of the prizes depend upon the number of entries received.
- d. Entrants must be present to enter. Entrants need not be present to win.
- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited and an alternate winner may be selected. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
