CONTEST OVERVIEW

Wisconsin football fans will have the chance to win an invite to the Bota Box Pregame event on Sunday, November 29 from 6-7PM CST via Zoom meeting. Fans must register to win by filling out the form via the contests page on www.botaboxpregame.com beginning on Tuesday, October 13, 2020 at 2PM CST and ending on Sunday, November 22, 2020 at 11:59PM CST. There will be one (1) grand prize winner selected at random from the eligible form entries. The winner will win the opportunity to invite nine (9) guests to join the Zoom event as well as a check for \$100. The ARV of the grand prize is \$300.00.

1. HOW TO ENTER

- a. These rules govern Bota Box Pregame (the "Promotion") being conducted by 94.5 ESPN, WKTI, 720 E Capitol Dr, Milwaukee, WI 53212 ("GKB") beginning on Tuesday, October 13, 2020 at 2PM CST and ending on Sunday, November 22, 2020 at 11:59PM CST.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Submit your online entry form at www.botaboxpregame.com
 - i. To participate in the Promotion, you may log onto www.botaboxpregame.com and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. There will be a total of one (1) winner randomly selected online for this Promotion to win the grand prize upon confirmation of eligibility. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 years or older and who reside in Wisconsin. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in Milwaukee and the surrounding area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win.  - Opportunity to invite up to nine (9) guests to join the Zoom event via the access link.
 - One (1) \$100 check.

The total ARV of the prize is \$300.00. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize. The winner must be at least 21 years of age at the time of their entry into the Promotion in order to be eligible to win the prize.

- b. The grand prize winner must complete the required prize forms and accept the prize by 5pm CST on Tuesday, November 24, 2020. If the selected winner does not accept by 5pm CST on Tuesday, November 24, 2020, a new winner will be selected in their place. There is no guarantee that the \$100 check will be delivered by the time of the Zoom event. GKB is not responsible for the safe arrival of a prize or prize certificate.
- c. The Bota Box Pregame event will be conducted online via Zoom. It is the responsibility of the fan and the fan's guests to join the Zoom link at 6PM CST on Sunday, November 29, 2020 to participate in the event. GKB reserves the right to change the date/time of the Zoom event in accordance with the 2020 NFL schedule. The winner will be notified prior to the event of any changes in the date/time.
- b. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. There will be one (1) winner selected at random from the online form at www.botaboxpregame.com to win the prize. GKB's promotions team will contact the winner via their provided email address by 5PM CST on Monday, November 23, 2020 to share the necessary prize forms.
- c. Odds of winning the Grand Prize depends upon the number of online entries received, the ability to meet the eligibility requirements, and random selection.
- d. Fans must complete the online entry form and be randomly selected in order to win.
- e. The one (1) winner will be contacted by phone number or email provided after they are selected to attend the virtual event. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release by Tuesday, November 24, 2020 at 5PM CST or the prize will be forfeited, and an alternate winner will be selected by random drawing. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize and another winner will be selected in their place.

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website.
