

BUD LIGHT® WINDY CITY TAKEOVER IN SAN FRANCISCO

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. HOW TO ENTER

- a. These rules govern the Bud Light Windy City Takeover in San Francisco sweepstakes (the “Sweepstakes”) being conducted by Good Karma Broadcasting, LLC dba ESPN Chicago, 190 N State St Suite 700, Chicago, IL 60601 (“GKB”) beginning on Friday, September 6, 2024 at 7am central time (“CT”) and ending on Sunday, November 3, 2024 at 9pm CT (“Sweepstakes Period”).
- b. To participate in the Sweepstakes for a chance to win one (1) of three (3) grand prizes (defined below), you may do any or all of the following:
 - i. attend a GKB street team appearance at one (1) of ten (10) select Chicagoland locations on:

Sunday, October 20, 7p-9p CT: Tap House Grill at 56 W Wilson St, Palatine, IL 60067;

Monday, October 21, 6p-8p CT: Fatty's at 1312 W Lincoln Hwy, DeKalb, IL 60115;

Sunday, October 27, 7p-9p CT: Gracie O'Malley's at 1635 N Milwaukee Ave, Chicago, IL 60647; (each a "Sweepstakes Date" and collectively referred to as "Sweepstakes Dates"); and,

- ii. play the football toss game ("Football Toss"). You must be the winner of the event you attend to win one (1) of ten (10) qualifying prizes and qualify for a chance to win a grand prize ("Qualifier").
 - a. Each game of Football Toss consists of each player throwing one (1) football into two (2) open slots which are marked with three (3) points and seven (7) points respectively. The one (1) player who scored the most points during their attempt will be deemed the winner of that Sweepstakes Date. Each player will be limited to ten (10) throws.
 - b. In the event of a tie at the end of any Sweepstakes Date, GKB will conduct a play-off round (or rounds, if needed) between the tied players in the same manner as the general round until the tie is broken. Each player will be limited to ten (10) throws per round.
- iii. Go to Chicagoland retail locations during the Sweepstakes Period and scan the QR Code on the Bud Light display ("QR Code Entry"); and,
- iv. Complete the online the entry form. One (1) grand prize winner will be selected from all eligible entries.
- v. Log onto www.x.com, be following @ESPN1000 and reply to a post from @ESPN1000 asking for a picture of your Gameday Fit to @ESPN1000 ("Gameday Fit Entry"). Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the X username submitted at the time of entry. Multiple participants are not permitted to share the same X usernames. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB's online submission release in order to submit his or her entry.

GKB is not responsible for lost, stolen, mangled, misdirected, postage due, illegible, incomplete or late entries.

- c. Entries can be made in-person at any one of the street team appearances on the Sweepstakes Dates, by scanning the QR code at area retailers, or via www.x.com.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 and who reside in Illinois. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, Anheuser-Busch, LLC, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. Up to (13) total prizes will be awarded in this Promotion.
- b. Up to four (4) qualifying prizes for each Sweepstakes Date from Thursday, September 26, 2024 through Monday, October 7, 2024 will be given out. Each qualifying prize will be one (1) YouTube NFL Sunday Ticket Promo Code with an Approximate Retail Value ("ARV") of \$449.
- c. Up to six (6) qualifying prizes for the Sweepstakes Dates from Thursday, October 10, 2024 through Sunday, November 3, 2024 will be given out. Each qualifying prize will be one (1) NFL Shop Promo Code with an Approximate Retail Value ("ARV") of \$150.
- d. Up to three (3) grand prizes will be given away. The grand prize will be a trip for (2) to San Francisco, CA and includes airfare, hotel and tickets to Bears-49ers on Sunday, December 8, 2024. The grand prize has an ARV of \$2,000. The Grand Prize consists of the following:

Roundtrip airfare for two people to San Francisco, CA from Chicago, Illinois, a 2-night hotel stay and (2) tickets to see the Chicago Bears at San Francisco 49ers on Sunday, September 8, 2024. The Approximate Retail Value ("ARV") of the prize is \$2,000. Certain travel restrictions may apply. Travel arrangements must be made through GKB. Prize is subject to availability. If the winner cannot travel on dates specified by GKB, the winner may be disqualified and an alternate winner may be selected in GKB's sole discretion. All other costs not specifically stated

The winner and travel companion(s) must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. Winner's one (1) guest must be twenty-one (21) years of age or older as of September 6, 2024. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the winner's stay. The winner and travel companion(s) must sign a Publicity, Liability Waiver and Travel Release form prior to traveling. If a selected event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, or for any reason beyond the control of the Station, the Station's sole responsibility to the winner will be to award the remaining available portion of the prize and no substitution or compensation will be provided for the unawarded portion of the prize.

The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Football Toss Grand Prize winner will be randomly selected by Thursday, October 31, 2024 at 5pm CT.
- c. QR Code Entry Grand Prize winner will be randomly selected by Monday, November 4, 2024 at 5pm CT.
- d. Gameday Fit Entry Grand Prize winner will be selected by the Carmen & Jurko show team by Monday, November 4, 2024 at 5pm CT.
- e. Odds of being selected as a Football Toss qualifier are dependent on total number of entries at each location. Odds of a Football Toss Qualifier winning the Grand Prize are 1 in 10.

- f. Odds of being selected as a Grand Prize winner via QR Code Entry are dependent on total number of entries.
- g. Odds of being selected as a Grand Prize winner via Gameday Fit Entry are dependent on total number of entries.
- h. Qualifying prize winners must be present to win. Grand Prize winner need not be present to win.
- i. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within two (2) days of winning or prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

If the Promotion is terminated before the original end date, GKB reserves the right to select the

winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.
- g. GKB is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
