

**CALLJACOB.COM LAFC SUITE NIGHT PROMOTION  
OFFICIAL RULES**

**1. HOW TO ENTER**

i. To participate in the Promotion, the authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB's online submission release in order to submit his or her entry.

ii. Sponsor is not responsible for winner notifications via texting that are the result of texting, computer or transmission errors and may cancel, modify or suspend the sweepstakes based upon any such error without liability at Sponsor's sole discretion. In the event than an error occurs, and more than the designated number of prizes are claimed, the designated number of

## 2. ELIGIBILITY RESTRICTIONS

## 5. CONDITIONS
