

## 2026 ESPN CHICAGO GRIP IT & SIP IT MULLIGAN CONTEST

### OFFICIAL RULES

***NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.***

#### 1. HOW TO ENTER

- a. These rules govern the 2026 ESPN Chicago Grip It & Sip It Mulligan Contest (the “Contest”) being conducted by Good Karma Broadcasting LLC dba ESPN Chicago, 141 W Jackson, Suite 1800, Chicago, IL 60604 (“GKB”) beginning on Thursday, May 14, 2026 at 6pm central time (“CT”) and ending on Thursday, June 11, 2026 at 9pm CT (“Contest Period”).
- b. To participate in the Promotion, you may enter via the following method(s): Attend any one (1) of the five (5) designated events to participate in and win a putting contest or closest to the pin contest to win a Twosome in the 2026 ESPN Chicago Grip It & Sip It Classic presented by Yuengling on Wednesday, June 17, 2026.
  - i. To participate in the Promotion, you must attend at least one (1) of five (5) ESPN Chicago events with talent appearances and win our putting contest to win a Twosome in the 2026 ESPN Chicago Grip It & Sip It Classic presented by Yuengling on Wednesday, June 17, 2026. For the events on the dates Thursday May 14, 2026, Thursday May 21, 2026, Thursday May 28, 2026, Thursday June 4, 2026, and Thursday June 11, 2026, each fan will have the opportunity to take one (1) practice putt followed by one (1) contest/qualifying putt, for each qualifying round of putts. Only fans who make the putt will advance to subsequent rounds, and the final fan to make/not miss their putt in the final round will win the final twosome on the related Team for the Golf Outing on Wednesday, June 17, 2026. If at the end of any events, there are multiple Putting Entries, each fan in the Putting Entries will then play in a playoff round (“Putt-off”). When a fan misses a putt in the Putt-off, they will be eliminated unless the Putt-off is down to the last two and both miss. The Putt-off would then continue until one fan has made a putt after the other fan has missed. The dates, times, and locations of these events are as follows:

Thursday May 14, 2026: 7p-9p CT at Corrigan’s Pub, 700 W Jefferson St. Shorewood, IL;

Thursday May 21, 2026: 6p-8p at Stadium Club, Stadium Club, 4740 Vernon Ave , McCook, IL;

Thursday, May 28, 2026: 7p-9p, Howard Street Inn, 6700 Howard Street, Niles, IL;

Thursday June 4, 2026: 7p-9p, Deacon's Restaurant and Bar at the Golf Farm, 2100 N US Hwy 12, Wauconda, IL;

Thursday, June 11, 2026: 6p-8p at Fire Bar and Grill, 435 Angela Ln, Crystal Lake, IL;

There will be one (1) winner at each event during the Contest Period.

- c. Entries can only be made by attending any of the five (5) designated ESPN Chicago events.

## 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 or older and who reside in Illinois, Indiana, or Wisconsin. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

## 3. PRIZES

- a. Up to (5) prizes will be awarded in this Promotion. Each prize consists of the following:

One (1) Twosome in the 2026 ESPN Chicago Grip It & Sip It Classic presented by Yuengling on Wednesday, June 17, 2026 taking place at Seven Bridges Golf Club in Woodridge, IL. The Approximate Retail Value ("ARV") of the prize is \$400. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. All prizes or prize certificates will be emailed to the winner. GKB is not responsible for the safe arrival of a prize or prize certificate.

- b. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. All winners will be selected and notified email by 5pm CT on Friday, June 12, 2026.
- c. Odds of winning a Prize depends upon the number and order of entries received at each designated event.
- d. Must listen to ESPN Chicago to win. Winners need not be present to win.
- e. The winner will be announced on air and notified via email. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within forty-eight (48) hours of winning or prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

#### 5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.
- b. By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.

Prior to awarding any prize(s) or prize certificate(s), GKB, in its sole discretion, may require Promotion winner(s) (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless GKB, its subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.

- d. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.
- g. GKB is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
