

# CIRCLE K SHOOTING STARS OF CLEVELAND

## OFFICIAL RULES

***NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.***

850 ESPN Cleveland will execute a contest to give away up to seventy-five (75) spots for fans to participate in the Circle K Shooting Stars of Cleveland competition on Saturday, April 20, 2024. The actual contest will take place at the Cleveland State Rec Center (2420 Chester Avenue, Cleveland, OH 44115) from 12:00PM to 4:00PM. The Circle K Shooting Stars of Cleveland competition includes a skills challenge and a shooting competition. The top finisher in each section will win one of the two grand prizes. Fans can enter for the chance to qualify for spot by scanning the QR code at Circle K locations and filling out the online entry form at [www.ESPNClevelandContests.com](http://www.ESPNClevelandContests.com) between the dates of Wednesday, February 21, 2024, and Thursday, April 11, 2024. A total of up to seventy-five (75) participants will be randomly selected and notified no later than Monday, April 15, 2024. A total of two (2) Grand Prizes will be awarded in this Promotion. Must be 18 years of age older at the time entry to participate and reside in the state of Ohio.

### 1. HOW TO ENTER

- a. These rules govern the Circle K Shooting Stars of Cleveland competition (the “Promotion”) being conducted by ESPN Cleveland, 1109 Old River Road, Cleveland, OH 44113 (“GKB”). The registration period for the contest will begin on Wednesday, February 21, 2024 at 4PM ET and end on Thursday, April 11, 2024 at 11:59PM ET. The shooting competition portion of the contest will take place on Saturday, April 20, 2024 at the CSU Rec Center (2420 Chester Avenue, Cleveland, OH 44115) from 12:00PM to 4:00PM ET.
- b. To participate in the Promotion, you may enter via the following method(s):
  - Locate a Circle K QR code at all Northeast Ohio Circle K locations to scan with a mobile device and follow the instructions to enter the promotion.
  - Complete the online register to win form at [www.ESPNClevelandContests.com](http://www.ESPNClevelandContests.com).
- i. To participate in the Promotion, you may scan the Circle K QR code at any one of their Northeast Ohio locations or log onto [www.ESPNClevelandContests.com](http://www.ESPNClevelandContests.com) and follow the links and instructions to enter the Promotion. You may be asked to submit your first and last name, complete address, city, state, zip code, telephone number, date of birth, and a valid email address in the online entry form. All potential winners are subject to verification and must meet the eligibility requirements as outlined in these contest rules before any prize will be awarded. There will be up to (75) total qualifiers randomly selected as a result of this Promotion. There will be two (2) Grand Prize winner as a result of this Promotion.

- ii. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems.
  - iii. Once a Qualifying Prize has been awarded, the qualifier must compete in the Circle K Shooting Stars of Cleveland contest on Saturday, April 20, 2024, in order to be eligible for either of the Grand Prizes, which will take place at the CSU Rec Center (2420 Chester Avenue, Cleveland, OH 44115) from 12:00PM to 4:00PM ET.
- c. Only one internet entry per person and one internet entry per email address is permitted.
  - d. Entrants must be 18 years or older to participate.

## 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years of age and above who reside in the state of Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in the Cleveland metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every thirty (30) days and only once every six (6) months if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Winners must be available to attend the contest event in person on Saturday, April 20, 2024 (location: CSU Rec Center – 2420 Chester Avenue, Cleveland, OH 44115 - from 12:00PM to 4:00PM ET).
- e. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements. GKB will also delete any entry

knowingly received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act.

### 3. PRIZES

a. Up to Seventy-Five (75) Qualifying Prizes will be awarded in this Promotion. Each prize consists of the following:

- Qualifying Prize: (1) spot in the Circle K Shooting Stars of Cleveland contest on Saturday, April 20, 2024 (location: CSU Rec Center – 2420 Chester Avenue, Cleveland, OH 44115 - from 12:00PM to 4:00PM ET).
- One (1) competition branded t-shirt.

The Approximate Retail Value ("ARV") of the shirt is \$20. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

b. Out of the fifty (75) Qualifying Prize winners, there is the opportunity to win a Grand Prize for First place in the skills challenge and a grand prize for First place in the shooting challenge, which includes the following in addition to the Qualifying Prize:

- Cash Prize valued at \$1,000
- Gift cards for Free Gas for a year valued at \$2,600. Number of gifts and denominations of each to be determined by GKB and Circle K.
- Two (2) Trophies

In addition to the experiential value of the Qualifying Prize, the Approximate Retail Value ("ARV") of the Grand Prize for the skills challenge is \$1,200 and the Approximate Retail Value ("ARV") of the Grand Prize for the shooting challenge is \$2,800. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize. The gift certificates will be subject to the terms and conditions as set forth by the issuer of the gift certificate.

c. All prizes or prize certificates must be picked up at the office of GKB at the address below. The winner will forfeit any prize or prize certificate not claimed within thirty (30) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.

d. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Participants will be notified by Monday, April 15, 2024, if they have been selected to participate in the Circle K Shooting Stars of Cleveland contest.
- c. Participants must RSVP by 11:59 PM ET on Thursday, April 18, 2024, or else the prize will be forfeited, and another winner will be randomly selected in their place.
- d. Participants must be present to qualify to receive the prizes on Saturday, April 20, 2024.
- e. Odds of winning a Qualifying Prize depends upon the number of entries in this competition. Odds of a qualifier winning one of the two Grand Prize on-site are dependent on the skill of each participant.
- f. Promotion of Skill: Skills Challenge
  1. On Saturday, April 20, 2024, 850 ESPN Cleveland and Circle K will conduct the Circle K Shooting Stars of Cleveland contest skills challenge (CSU Rec Center – 2420 Chester Avenue, Cleveland, OH 44115 - from 12:00PM to 4:00PM ET).
  2. The registration period to win a Qualifying Prize of (1) non-transferrable spot in the Circle K Shooting Stars of Cleveland contest will begin on Wednesday, February 21, 2024, at 4PM ET and will end on Thursday, April 11, 2024, at 11:59 PM ET.
  3. All participants must have a valid picture ID and be at least 18 years of age or older.
  4. All participants must abide by the designated health and safety protocols.
  5. All participants must complete a liability/waiver form in order to participate.
  6. The hoop will be at a standard height of ten (10) feet, no higher or lower.
  7. Gameplay will proceed as follows:
    - a. Each participant will be timed to complete the skills challenge, consisting of a chest pass, dribble around three (3) obstacles, a layup, then run the full court to get back to the start and shoot a layup in that order.
      - i. Participants may not advance to the next section until they have executed a completed each stage.
        1. Participants will start with the chest pass into a net. Once the participant makes a pass, they can advance to dribble around the three (3) obstacles. Once the participant dribble around the three (3) obstacles, they will advance to the the basket and shoot a layup. Once that is made, they will run the full court back to the starting side and will shoot a layup.
      - ii. Participants have unlimited attempts at each stage and must successfully complete each stage before advancing.

- iii. Each participant's round ends when they successfully complete the second layup.
  - b. The participant with the fastest round time will be awarded the Grand Prize of \$1,000 cash prize and trophy.
    - i. If there is a tie between participants who completed the four skills quickest, those participants will move to another skills challenge tiebreaker.
    - ii. The four-skill process will continue round-after-round until a participant completes the four-skill challenge in the quickest time.
- g. Promotion of Skill: Shooting Challenge
  - 1. On Saturday, April 20, 2024, 850 ESPN Cleveland and Circle K will conduct the Circle K Shooting Stars of Cleveland contest shooting challenge (CSU Rec Center – 2420 Chester Avenue, Cleveland, OH 44115 - from 12:00PM to 4:00PM ET).
  - 2. The registration period to win a Qualifying Prize of (1) non-transferrable spot in the Circle K Shooting Stars of Cleveland contest will begin on Wednesday, February 21, 2024, at 4PM ET and will end on Thursday, April 11, 2024, at 11:59 PM ET.
  - 3. All participants must have a valid picture ID and be at least 18 years of age or older.
  - 4. All participants must abide by the designated health and safety protocols.
  - 5. All participants must complete a liability/waiver form in order to participate.
  - 6. The hoop will be at a standard height of ten (10) feet, no higher or lower.
  - 7. Gameplay will proceed as follows:
    - a. Each participant will have 120 seconds to complete the four-shot challenge, consisting of a lay-up, a free throw, a three-point shot, and a half-court shot, in that order.
      - i. Participants may not advance to the next shot in the order until they have executed a made basket on whatever stage they are on.
        - 1. Participants will start with the lay-up. Once the participant makes a lay-up, they can advance to the free throw. Once the participant makes a free throw, they will advance to the three-pointer. Once that is made, they move to the final stage of the half-court shot.
      - ii. Participants have unlimited attempts at each stage and must make that basket before advancing.
      - iii. Each participant's round ends when they successfully complete the half-court shot, or at the end of 120 seconds from the start of their round, whichever comes first.
    - b. The participant with the fastest round time will be awarded the Grand Prize of free gas for a year and trophy.
      - i. If no participants successfully complete all four shots, tiebreaker will be determined by which participant completed the three-point shot quickest.
      - ii. If there is a tie between participants who completed the three-point shot quickest, those participants will move to another four-shot tiebreaker.

- iii. The four-shot process will continue round-after-round until a participant completes the four-shot challenge, or until one participant has the quickest time to complete the three-pointer.
- h. Qualifiers must be present day of the event during the specified times in order to win any of the prizes.
- i. All qualifiers of the Circle K Shooting Stars of Cleveland contest will be notified they have been selected to compete by phone, with the phone number they provided on their online submission form. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release prior to the start of the event. Extra copies will be provided on-site on Saturday, April 20, 2024, and must be completed prior to participation. Any paperwork not submitted at this time will result in the prize being forfeited with no replacement. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

## 5. CONDITIONS

in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.
