

ESPN CLEVELAND CLINCH GOGGLES CONTEST 2023-24

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

ESPN Cleveland is giving fans a chance to win a tailgate-themed prize pack in celebration of an unforgettable football season. Qualification for the contest will start on Friday, December 29, 2023 at 10AM EST. To qualify, fans must post a video of their best celebration to Twitter or Instagram and tag @ESPNCleveland or upload their video and fill out the entry form on www.ESPNClevelandContests.com. The qualification period will end at 11:59PM EST on Sunday, January 7, 2024 at 11:59PM EST. ESPN Cleveland team members will then select one (1) grand prize winner based on each eligible submission's featuring of the ESPN Cleveland "Clinch Goggles," creativity, and presentation. The grand prize winner will receive a tailgate-themed prize pack, which is valued at \$250. All entrants must be 21 years of age or older and reside in the greater Cleveland area.

1. HOW TO ENTER

- a. These rules govern the ESPN Cleveland Clinch Goggles Contest 2023-24 promotion (the "Promotion") being conducted by ESPN Cleveland, 1109 Old River Road, Cleveland, Ohio 44113 ("GKB") beginning on Friday, December 29, 2023 at 10AM EST and ending on Sunday, January 7, 2024 at 11:59PM EST.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Post a video of your best celebration featuring your ESPN Cleveland "Clinch Goggles" and tag @ESPNCleveland on Twitter or Instagram.
 - Upload a video of your best celebration video featuring your ESPN Cleveland "Clinch Goggles" on www.ESPNClevelandContests.com and fill out the online entry form.
- i. To participate in the Promotion, you may visit www.twitter.com or the Twitter app on your smart device or www.instagram.com or the Instagram app on your smart device. Then, post a video of your best celebration video featuring your ESPN Cleveland "Clinch Goggles" and tag @ESPNCleveland ("the Page") in the post. If you do not already "Follow" the Page, you must "Follow" the Page in order to access the Promotion. You must have a valid corresponding social media account in order to enter. If you do not already have one, you can create a corresponding social media account at no cost by visiting either of the aforementioned links or apps. You must also have your DMs open for an ESPN Cleveland representative to contact you. When contacted, you may be asked to provide some information such as your first and last name, complete address, city, state, zip code, telephone number, date of birth, and/or a valid email address. Limit one (1) entry per eligible person during the Entry Period

regardless of if entrant has more than one Twitter or Instagram account. Multiple participants are not permitted to share the same Twitter or Instagram account. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by GKB. Internet entrants are subject to all notices posted online but not limited to GKB's Privacy Policy. Use of Twitter or Instagram as a means of entry will be subject to both Twitter and Instagram's respective privacy policies and terms of service. By participating in the Promotion, entrant understands that he or she is providing his or her information to GKB and not Twitter and/or Instagram. Further, entrant specifically agrees to release Twitter and/or Instagram from any and all liability associated with this Promotion. The Promotion is in no way sponsored, endorsed, or administered by, or associated with, Twitter or Instagram.

- ii. To enter this Promotion, you may log onto www.ESPNClevelandContests.com and follow the links and instructions to enter the Promotion and submit a video of your best celebration featuring your ESPN Cleveland "Cinch Goggles" along with the following information: your first and last name, complete address, city, state, zip code, telephone number, date of birth, and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB's online submission release in order to submit his or her entry.
- c. Limit one (1) entry per eligible person during the entry period regardless of the platform that fans choose to post their video, whether on Twitter, Instagram, or www.ESPNClevelandContests.com.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 years of age or older and who reside in Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the Cleveland metropolitan area, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether

related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited.

- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide their complete address, date of birth, and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. One (1) Grand Prize will be awarded in this Promotion. The Grand Prize consists of the following:
 - One (1) tailgate-themed prize pack

The Approximate Retail Value (“ARV”) of the prize is \$250. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. All prizes or prize certificates may be picked up at the office of GKB at the address below. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- b. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.

- b. The Grand Prize winner with the best video will be selected and notified by 9PM EST on Monday, January 8, 2024.
- c. Promotion of Skill:
 - All eligible entrants' video submissions will be judged based on the following criteria: Inclusion of ESPN Cleveland "Clinch Goggles," Creativity, and Presentation.
 - Judging and final selection of the Grand Prize winner will be conducted by an ESPN Cleveland panel of judges.
- d. The Grand Prize winner need not listen to ESPN Cleveland to win. The Grand Prize winner need not be present to win.
- e. The Grand Prize winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited, and an alternate winner may be selected by going to the next highest rated eligible contestant. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
