

DRR OFFROAD SEASON OF GIVING CONTEST 2023

OFFICIAL RULES

(Revised 12/21/23 with updated selection process details)

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

ESPN Cleveland and DRR Offroad are giving fans the chance to win a free electric motorcycle or \$500 in cash this holiday season. Fans may enter by filling out the online registration form at www.ESPNClevelandContests.com. The entry period for the contest will begin at 9:00AM ET on Monday, December 4, 2023 and close at 11:59PM ET on Sunday, December 17, 2023. Fans must be 18 years of age or older as of the date of entry and from the state of Ohio to be eligible for the contest. There will be four (4) Secondary Prize winners of the \$500 cash prize and one (1) Grand Prize winner of the electric motorcycle. The Approximate Retail Value of the Secondary Prize is \$500 and \$8,299 for the Grand Prize.

1. HOW TO ENTER

- a. These rules govern the DRR Offroad Season of Giving Contest 2023 promotion (the "Promotion") being conducted by ESPN Cleveland, 1109 Old River Road, Cleveland, Ohio 44113 ("GKB") beginning at 9:00AM ET on Monday, December 4, 2023 and ending at 11:59PM ET on Sunday, December 17, 2023.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Complete the online register-to-win form at www.ESPNClevelandContests.com.
 - i. To participate in the Promotion, you may log onto www.ESPNClevelandContests.com and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion.

c. Only one internet entry per person and one internet entry per email address is permitted.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years or older and who reside in Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the Cleveland metropolitan area, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth, and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. One (1) Grand Prize will be awarded in this Promotion. The prize will consist of the following:

- One (1) Electric Motorcycle DR-X EV

The Approximate Retail Value ("ARV") of the prize is \$8,299. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. Four (4) Secondary Prizes will be awarded in this Promotion. Each prize consists of the following:

- One (1) cash prize of \$500

The Approximate Retail Value ("ARV") of the prize is \$500. The winner will be solely responsible for all taxes and all other fees and expenses not specified

herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- c. All prizes or prize certificates may be picked up at the office of GKB at the address below. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- b. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. There will be a total of four (4) Secondary Prize winners randomly selected and notified between the hours of 9:00AM ET and 6:00PM ET on each of the following four (4) selection dates: Wednesday, December 6, 2023; Friday, December 8, 2023; Wednesday, December 13, 2023; and Friday, December 15, 2023.
- c. There will be a total of one (1) Grand Prize winner randomly selected and notified live on-air during The Really Big Show between the hours of 9:00AM ET and 1:00PM ET on Thursday, December 21, 2023.
 - The grand prize winner will be randomly selected and called live on air. If the first randomly selected winner does not answer, another randomly selected winner will be called. This process will be repeated until a winner answers the phone. That person will be declared the grand prize winner.
- d. Odds of winning a prize in this Promotion depends upon the number of entries received, the ability to meet eligibility requirements, and random selection.
- e. All winners need not listen to 850 ESPN Cleveland to win. All winners need not be present to win.
- f. The winners must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited and an alternate winner may be randomly selected. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

- d. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the

control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.
