

TWISTED TEA TICKET GIVEAWAY

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

850 ESPN Cleveland and Twisted Tea are giving away two (2) tickets to the Cleveland football game against Arizona in Cleveland, OH and a \$200 Gift Card. The game will take place at 1PM ET on Sunday, November 5th at 100 Alfred Lerner Way, Cleveland, OH 44114. Fans may enter the contest by scanning the Twisted Tea QR code at all participating retail locations in Northeast Ohio and filling out the registration form online at www.ESPNclevelandContests.com. The contest will start on Sunday, October 1, 2023, and end on Tuesday, October 31, 2023. There will be one (1) Grand Prize winner randomly selected for this contest. Must be 21 years of age or older at time of entry and only one (1) internet entry per person will be allowed. The total ARV of the Grand Prize is \$600.

1. HOW TO ENTER

- a. These rules govern the Twisted Tea Ticket Giveaway contest (the "Promotion") being conducted by ESPN Cleveland, 1109 Old River Road, Cleveland, OH 44113 ("GKB") beginning on Sunday, October 1, 2023, at 12AM ET and ending on Tuesday, October 31, 2023, at 11:59PM ET.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Locate a Twisted Tea QR code at all participating retail locations in Northeast Ohio to scan with a mobile device and follow the instructions to enter the promotion.
 - Complete the online register to win form at www.ESPNclevelandContests.com.
- i. To participate in the Promotion, you may scan the QR code at any one of Twisted Tea's participating Northeast Ohio retail locations or log onto www.ESPNclevelandContests.com and follow the links and instructions to enter the Promotion. You may be asked to submit your first and last name, complete address, city, state, zip code, telephone number, date of birth, and a valid email address in the online entry form. All potential winners are subject to verification and must meet the eligibility requirements as outlined in these contest rules before any prize is awarded. There will be one (1) Grand Prize winner as a result of this Promotion.
- ii. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for

assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems.

- c. Only one internet entry per person and one internet entry per email address is permitted.
- d. Entrants must be 21 years or older to participate.
- e. The selected winner must be available to attend the game on Sunday, November 5, 2023, in order to be eligible to win.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 years of age or older and who reside in the state of Ohio at the time of entry. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.

3. PRIZES

- a. One (1) Grand Prize will be awarded in this Promotion. Each prize consists of the following:

- Two (2) tickets to the Cleveland professional football game against Arizona on Sunday, November 5, 2023, at 1PM.
- \$200 Gift Card

The Approximate Retail Value (“ARV”) of the Grand Prize is \$600. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize. The gift card will be subject to the terms and conditions as set forth by the issuer of the gift card.

- b. The tickets will be emailed to winner to the email address provided and the gift card will be mailed to the winner with the address provided. The winner will forfeit any prize or prize certificate not claimed within twenty (20) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer, or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities, or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. The Grand Prize winner will be randomly selected and notified by phone by ESPN Cleveland representatives of winning on Wednesday, November 1, 2023, between 9AM ET and 6PM ET.
- c. Odds of winning the grand prize depends upon the number of eligible entries received.
- d. The Grand Prize winner need not listen to 850 ESPN Cleveland to win. The winner need not be present to win.
- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within two (2) days of winning or the prize will be forfeited, and an alternate winner may be randomly selected. If a potential winner cannot be contacted, fails to sign, and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes.
