OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. HOW TO ENTER

- a. These rules govern the ESPN LA COPA AMERICA WATCH PARTY PROMOTION PRESENTED BY MERCADO GONZALEZ NORTHGATE MARKET (the "Promotion") being conducted by Good Karma Broadcasting, dba ESPN Los Angeles, 800 W. Olympic Blvd Suite 200, Los Angeles CA 90015 ("GKB") beginning on Monday, June 24, 2024, at 10:00 AM PT and ending on Monday, July 1, 2024, at 5:00 PM PT
- b. To participate in the Promotion, you may enter via the following method(s): Visit espnla.com/contest and complete the online nomination form during the Promotion Period and confirm eligibility requirements.
- c. To participate in the Promotion, you may log onto espnla.com/contest and follow the links and instructions to enter the Promotion and submit your first and last name, telephone number, a valid email address, and check off any required checkboxes in the online entry form.
- d. Only one internet entry per nominee and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB's online submission release in order to submit his or her entry.
- e. Only one internet entry per email address is permitted.

2. ELIGIBILITY RESTRICTIONS

- To enter, you must be 21 years of age or older as of entry. All nominees must reside in the Southern California metropolitan area. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the Los Angeles

metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

- Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600.

- ESPN Los Angeles' Marketing team will select and determine the winner at random.
- Odds of winning depends upon the number of entries received

 - The winners must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited and an alternate winner may be selected by the same method as above. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.
