There will be a total of nine (9) winners selected in this promotion. The total ARV of each prize is \$44.

1. HOW TO ENTER

These rules govern the ESPN LA On Air - COSM Admission - 01/24/25 GIVEAWAY

a. – 01/24/2025 Giveaway being conducted by ESPN LA – Good Karma Brands 800 W Olympic Blvd. Los Angeles CA, 90015, Suite #200 (“GKB”) on Friday, January 24, 2025.

b. To participate in the Promotion, you may enter via the following method(s): Being the correct caller, caller number seven (7), when you hear the cue to call on KSPN-AM 710 between the hours of 9:00 AM PT and 5:00 PM PT on Friday, January 25, 2025.

i. To participate in the Promotion, you must listen to KSPN-AM 710 on Friday, January 24, 2025, between the hours of 9:00 AM PT to 5:00 PM PT and listen for

the announcement of the cue to call. Upon hearing the cue to call by the on-air personality or producer prior to the cue to call, caller number seven (7) to get through to the GKB contest line at 877-710-ESPN will win a pair of tickets (2) to see Lakers vs. Warriors at COSM in Inglewood on Saturday, January 26, 2025, upon confirmation of eligibility. At the time of their call, the winner will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers and date of birth to be eligible to win. If the selected winner is disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the call-in line and completes their call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once.

Fans must call into KSPN-AM and get through to the GKB contest line at 877-710-ESPN will win a pair of tickets (2) to see Lakers vs. Warrior at COSM in Inglewood on Saturday, January 25, 2025.
- c. Fans must listen to KSPN-AM 710 to win. Winners need not to be present to win.
