

# CHICAGO'S COLLEGE TAILGATE WATCH PARTY SWEEPSTAKES

## OFFICIAL RULES

***NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.***

### 1. HOW TO ENTER

- a. These rules govern the Chicago's College Tailgate Watch Party Sweepstakes (the "Sweepstakes") being conducted by Good Karma Broadcasting, LLC dba ESPN Chicago, 190 N State St Suite 700, Chicago, IL 60601 ("GKB") beginning on Saturday, October 26, 2024 at 11:00am central time ("CT") and ending on Saturday, November 2, 2024 at 1:00pm CT ("Sweepstakes Period").
- b. To participate in the Sweepstakes for a chance to win one (1) of two (2) prizes (defined below), you may:

- i. attend an ESPN Chicago Chicago's College Tailgate Watch Party at select Twin Peaks locations (each a "Location" and collectively referred to as "Locations") from 11:00am-1:00pm CT on select dates during the Sweepstakes Period (each a "Sweepstakes Date" and collectively referred to as the "Sweepstakes Dates"):

Saturday, October 26, 11:00am-1:00pm CT: Twin Peaks at 28252 Diehl Rd, Warrenville, IL 60555; and,

Saturday, November 2, 11:00am-1:00pm CT: Twin Peaks at 17W744 W 22nd St Suite A, Oakbrook Terrace, IL 60181; (each a "Sweepstakes Date" and collectively referred to as "Sweepstakes Dates"); and,

- ii. visit the ESPN Chicago street team and get a raffle ticket.

- c. You may have a maximum of one (1) entry per Sweepstakes Date. Entries can be made in-person only at Locations on Sweepstakes Dates.

### 2. ELIGIBILITY RESTRICTIONS

- a. The Sweepstakes is open to all persons who are 18 years old or older as of Saturday, October 26, 2024, and who reside in Illinois, Indiana, or Wisconsin. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited.

- b. Up to one (1) entry per person per Sweepstakes Date. Entrants are eligible to win a prize in only one (1) sweepstakes or promotion conducted by GKB, including this Sweepstakes, once every seven (7) days and once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. Entrants are required to provide truthful information. GKB will reject and delete any entry that it determines, in its sole and absolute discretion, to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

### 3. PRIZES

- a. Up to one (1) prize per Sweepstakes Date will be awarded for a total of two (2) prizes during the Sweepstakes Period (each, a "Prize" and collectively, "Prizes").
- b. Each Prize will include one (1) ESPN Chicago Prize Pack ("Prize Pack") with a total approximate retail value ("ARV") of \$200 for all two (2) of the Prizes (each, a "Prize Winner" and collectively, "Prize Winners"). Each Prize Winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize including, but not limited to transportation to and from Soldier Field and food and beverages purchased at Soldier Field. GKB accepts no responsibility for any liability arising out of each winner's acceptance or use of the Prize.
- c. All Prizes or Prize certificates will be either emailed or mailed to each Prize Winner. GKB is not responsible for the safe arrival of a Prize or Prize certificate.
- d. There is no substitution, transfer, or cash equivalent for the Prizes, except that GKB may, at its sole discretion, substitute Prizes for cash of comparable value. The Prizes are expressly limited to the item(s) listed above and, unless otherwise expressly specified, do not include taxes, gratuities or any other expenses including travel, lodging, or food. Other restrictions may apply.

### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Sweepstakes are final.
- b. Prize Winners will be randomly selected by 5pm CT the next business day after each Sweepstakes Date, provided that there is an eligible Entrant for each Sweepstakes Date.
- c. Odds of winning a Prize are dependent on total number of Entries each Sweepstakes Date.

- d. Prize Winners must be present at the time of the random drawing to win.
- e. Each Prize Winner must execute and return any required affidavit of eligibility and/or liability/publicity release within five (5) days of winning or Prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a Prize or Prize notification is returned as undeliverable, the potential winner forfeits the Prize. GKB reserves the right to select another winner from all eligible Entrants if a Prize is forfeited.

## 5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of each winner. Each Prize Winner will be required to complete and submit an IRS Form W-9 with the Prize Winner's full Social Security Number or the equivalent for receipt of any Prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the Prize. Such winnings of \$600 or more will be reported to the IRS.
- b. By participating in the Sweepstakes, each Prize Winner agrees to have their name, voice and likeness used in any advertising or broadcasting material relating to the Sweepstakes without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the Prize.
- c. If for any reason this Sweepstakes cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Sweepstakes, or if the Sweepstakes is compromised or becomes technically corrupted in any way, electronically or otherwise, GKB reserves the right to cancel, terminate, suspend, or modify the Sweepstakes. If the Sweepstakes is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- d. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Sweepstakes may result in a contestant's disqualification and/or forfeiture of any Prize or Prizes. If GKB makes a good faith determination that an Entrant has cheated or committed fraudulent activity in connection with a Sweepstakes, GKB reserves the right to disqualify that Entrant from entering and/or winning future Sweepstakes and to prosecute and seek damages to the fullest extent permitted by law.

- e. GKB reserves the right to make changes in the rules of the Sweepstakes, including, without limitation, the substitution of a Prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or Prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Sweepstakes and shall not be required to award a substitute prize.
- f. **GOVERNING LAW.** All issues and questions concerning the construction, validity, interpretation, and enforceability of these official rules or the rights and obligations of the Entrants, GKB, or released parties in connection with the Sweepstakes shall be governed by and construed in accordance with the laws of the state of Illinois without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws.
- g. **ENTRANTS' PRIVACY.** Any personally identifiable information collected in connection with an Entrant's participation in this Sweepstakes will be used by GKB, its respective affiliates, and agents only for purposes of the proper administration and fulfillment of the Sweepstakes, as described in these Official Rules, and in any manner consistent with GKB's respective Privacy Policy, available at <https://goodkarmabrands.com/privacy-policy/> Any Entries that are not selected to win the Prizes will be discarded at the end of the Sweepstakes Period. GKB is not responsible for lost, stolen, mangled, misdirected, postage due, illegible, incomplete or late entries.
- h. GKB is not responsible for typographical or other errors in the printing, the offering or the administration of the Sweepstakes or in the announcement of a prize.
