OFFICIAL RULES

850 ESPN Cleveland and Circle K are giving fans the chance to win free gas for a year. Fans may enter by posting a video of their best sports trick shot on Twitter starting on Sunday, October 30, 2022. It does not matter which sport fans base their trick shot on, but fans must post the video using the hashtag #CircleKTrickShot and tagging @ESPNCleveland in the Tweet. Submissions will be accepted through Sunday, November 27, 2022. After submissions close, a panel of ESPN Cleveland judges will review each submission and score each one on a scale of 1-10 on both creativity/ingenuity and difficulty. The person with the highest cumulative score with be deemed the winner. There will be only one winner in this contest, and they will win free gas for a year from Circle K, which is valued at \$2,600.

1. HOW TO ENTER

- **a.** These rules govern the Circle K Trick Shot Challenge contest (the "Promotion") being conducted by ESPN Cleveland, 1109 Old River Road, Cleveland, OH 44113 ("GKB") beginning on Sunday, October 30, 2022, at 12AM EST and ending on Sunday, November 27, 2022, at 11:59PM EST.
- To participate in the Promotion, you may enter via the following method(s): Tweet out a video of your best trick shot, no matter the sport, using the hashtag #CircleKTrickShot and tag @ESPNCleveland on Twitter.
 - To participate in the Promotion, you may visit http://www.twitter.com or the Twitter app on your smart device to post a video of your best sports trick shot. The trick shot can involve any sport, but you must use the hashtag #CircleKTrickShot and tag @ESPNCleveland ("the Page") in the post. If you do not already "Follow" the Page, you must "Follow" the Page in order to access the Promotion. You must have a valid Twitter account in order to enter. If you do not already have one, you can create a Twitter account at no cost by visiting http://www.twitter.com. Limit one (1) entry per eligible person during the Entry Period regardless of if entrant has more than one Twitter account. Multiple participants are not permitted to share the same Twitter account. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by GKB. Internet entrants are subject to all notices posted online including but not limited to GKB's Privacy Policy. Use of Twitter as a means of entry will be subject to Twitter's privacy policy and terms of service. By participating in the Promotion, entrant understands that he or she is providing his or her information to GKB and not Twitter. Further, entrant specifically agrees to release Twitter from any and all liability associated with this Promotion. The

c. Entries can only be made via Twitter by tweeting a picture of your college years using the hashtag #CircleKTrickShot and tagging the @ESPNCleveland Twitter account in your post. Only one entry per user is allowed.

2. **ELIGIBILITY RESTRICTIONS**

- a. The Promotion is open to all persons who are 18 years of age or older and who reside in the state of Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. One (1) prize will be awarded in this Promotion. Each prize consists of the following:
 - Free Gas for one (1) year (Five (5) \$500 Circle K Gas Cash cards and one (1) \$100 Circle K cash card)

The Approximate Retail Value ("ARV") of the prize is \$2,600 paid out by five (5) \$500 Circle K Gas Cash cards and one (1) \$100 Circle K Gas Cash card. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. The Circle K Gas Cash cards must be picked up at the ESPN Cleveland office 1109 Old River Road, Cleveland, OH 44113. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. The winner will be selected between Monday, November 28, 2022, and Friday, December 2, 2022. The winner will be selected by a panel of ESPN Cleveland judges based on the trick shot video submissions that are received. The winner will be notified by an ESPN Cleveland representative by 5PM EST on Monday, December 5, 2022.
- c. All eligible entries will be judged on creativity/ingenuity and on trick shot difficulty.
 - A panel of ESPN Cleveland judges will view each video submission and rate the creativity/ingenuity of the trick shot on a scale of 1-10.
 - A panel of ESPN Cleveland judges will view each video submission and rate the difficulty of the trick shot on a scale of 1-10.
 - Each winner will receive cumulative score from their creativity/ingenuity rating along with their difficulty rating.
 - The highest cumulative score submission will be deemed the winner.
 - o If there is a tie of cumulative scores, the first tiebreaker will be highest individual category score: i.e., if two submissions were to receive a final score of 18 where one submission receives a 9 in creativity/ingenuity and a 9 in difficulty, while the other submission receives a 10 in creativity/ingenuity and receives an 8 in difficulty; the submission that received the 10 in an individual category would be deemed the winner.
 - o If there is a tie of cumulative scores and individual category scores, the second tiebreaker will be a tiebreaking judge viewing the tied submissions. The tiebreaker judge will rate each submission on a scale of 1-10 on creativity/ingenuity and on a scale of 1-10 on difficulty. The highest cumulative score from the tiebreaking judge will be deemed the winner.

- d. The winner need not listen to 850 ESPN Cleveland to win. The winner need not be present to win
- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited, and an alternate winner may be selected by the ESPN Cleveland judging panel. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. - e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website.
