The contest will start on Friday, October 7, 2022 and end on Friday, October 28, 2022. There will be (4) winners randomly selected for this contest. Must be 18 years of age or older to enter and only (1) internet entry per person will be allowed. The total ARV of the grand prize is \$109.

1. HOW TO ENTER

a. These rules govern the ESPNLA/The Red Chickz Football Party Pack promotion being conducted by **ESPNLA 710, 800 W. Olympic Blvd., Los Angeles, CA** ("GKB") beginning on 12:00 AM, 10/7/2022 and ending on 11:59 PM, 10/28/22.

a. To participate in the Promotion, you may enter via the following method(s): (1) GO TO A RED CHICKZ LOCATION (557 S. Spring St., Los Angeles, CA and/or 10100 Venice Blvd. Culver City, CA), SCAN QR CODE, FILL OUT NECESSARY FIELDS TO WIN FOOTBALL PARTY PACK.

i. To participate in the Promotion, you may log onto goodkarmabrands.com/espn-la-contests/espnla-the-red-c...ty-pack-giveaway/ and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. 1. ELIGIBILITY RESTRICTIONS

- e. The winner need not listen to 710 ESPN Los Angeles to win. The winner need not be present to win.
 - a.
