

## 2018 Coors Light Bracket Challenge

### OFFICIAL RULES

***NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.***

#### 1. HOW TO ENTER

- a. These rules govern the 2018 Coors Light Bracket Challenge promotion (the "Promotion") being conducted by ESPN 850 WKNR ("GKB") beginning on Thursday, March 1, 2018 at 9:00am and ending on Friday, March 9, 2017 at 7:00pm.
- b. To participate in the Promotion, you may enter via the following method(s):  
Listening to ESPN 850 WKNR weekdays between 9am and 7pm. Call in to the show at 216.578.0850 when prompted. Successful entries will be required to attend the Selection Sunday Party at Punch Bowl Social in order to be assigned a team in the bracket challenge.
  - i. To participate in the Promotion, you must listen to ESPN 850 WKNR each day beginning on March 1, 2018 and ending on March 9, 2018 between the hours of 9am to 7pm weekdays during the promotion dates for the announcement of the cue to call. Upon hearing the cue to call, the designated number caller (as announced by the on-air personality prior to the cue to call) to get through to the GKB line at 216.578.0850 win an entry into a bracket challenge for a chance to win a grand prize upon confirmation of eligibility. At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the call-in line and completes their call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once. There will be up to a total of 30 winners selected on-air during the Promotion dates. Each on-air winner will be permitted to bring a guest. GKB is not responsible for telephone service outages, delays, busy signals, equipment malfunctions or any other technological difficulties that may prevent an individual from completing his/her telephone call. Due to delays in the GKB online streaming of its broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air contests.
- c. Entries can only be made by listening to ESPN 850 WKNR during the promotion dates and calling in when prompted by on-air hosts. Successful entries will win entrance to the Punch Bowl Social Selection Sunday Party on March 11, 2018 and

be assigned a team in the bracket challenge on that date. All entrants will receive one of 64 teams in the bracket.

## 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 and who reside in Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every thirty (30) days and only once every six (6) months if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

## 3. PRIZES

- a. \$1000 cash for the grand prize winner of the bracket challenge. Second place winner will receive a Coors Light Neon light. Third place winner will receive a golf card (\$100). Fourth place winner will receive a one-year subscription to The Land on Demand (\$85). Prizes will be awarded in this Promotion. Each prize consists of the following:

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. The fans assigned to the teams that advance into the last 4 teams of the NCAA Tournament will receive a prize as outlined.
- c. Winners will be selected following the NCAA Tournament finals on April 3, 2018.
- d. The fans assigned to the teams that advance into the last 4 teams of the NCAA Tournament will receive a prize as outlined.
- e. The final winner will be determined upon completion of the NCAA Tournament finals on April 3, 2018.
- f. Odds of winning a Qualifying Prize depends upon the number and order of calls received. Odds of a Qualifier winning the Grand Prize are 1 in 60.

- g. Qualifiers must listen to ESPN 850 WKNR and be present at Punch Bowl Social for the Selection Sunday Party to win. Qualifiers need be present at Punch Bowl Social for the Selection Sunday Party to be given a team.
- h. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website.
