

Coors Light Yet Giveaway (Giant Eagle)

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. HOW TO ENTER

- b. To participate in the Promotion, you may enter via the following method(s): Visit participating Giant Eagle locations in the Cleveland area and find the Labatt Blue text-to-win display with the text code. Text the code on display to "31996". Once you text, you will receive a confirmation.
- c. Limit to one entry per phone number.
- d. Entrants must be 21 years or older to participate.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 and who reside in Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. - v. Winners will be contacted on October 29th by someone from ESPN Cleveland.
- w. Ten winners will be selected on November 2nd.
- x. Winners will be contacted on November 5th by someone from ESPN Cleveland.

- y. Five winners will be selected on November 10th.
- z. Winners will be contacted on November 12th by someone from ESPN Cleveland.
- aa. Twenty winners will be selected on November 17th.
- bb. Winners will be contacted on November 19th by someone from ESPN Cleveland.
- cc. Odds of winning a Prize depends upon the number of entries received.
- dd. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited, and an alternate winner may be selected by random selection from remaining entries.
