- a. (6) Grand Prizes will be awarded in this Promotion. Each Grand Prize is of equal value and consists of the following:

The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. A total of (6) gift cards will be awarded, one for each winner. The gift card can be used at participating Cousins Subs restaurants as specified by the issuer of the gift card. The gift certificate will be subject to the terms and conditions as set forth by the issuer of the gift certificate.

b. All prizes or prize certificates may be picked up at the office of GKB at the address below. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and

- therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.

### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Winners will be randomly selected from the prize pool of those who answered the trivia question correctly following the 24-hour promotional period they have to answer the question. There will be a six questions throughout the promotional period and one winner for each question.
- c. Final winners will be known by Monday, March 19th 2018 at 5 PM CST.
- d. Odds of winning a Grand Prize depends upon the number of participants that answer the trivia question correctly and are entered into the prize pool. Prize pool resets after each questions 24 hour promotional period.
- e. Winners will be notified through there Facebook or Twitter account they used to submit their entry in the promotion. They will be notified the day after the 24 promotional period of each question. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited and an alternate winner may be selected by randomly selecting a winner from the same prize pool.
