

CRAWL TO SPRING TRAINING

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. HOW TO ENTER

- a. These rules govern the Crawl to Spring Training promotion (the “Promotion”) being conducted by ESPN Chicago, 190 N State St. Chicago, IL 60601 (“GKB”) beginning on January 12th, 2020 at 3pm CT and ending no later than February 19th, 2020 at 5PM CT.
- b. To participate in the Promotion, you may enter via the following method(s): visit the ESPN Chicago Street Team to get a raffle ticket during one of four bar crawls with an ESPN Chicago appearance. Three qualifying winners will be chosen at each of the bar crawls, one at each bar. After all four bar crawls, a winner will be chosen on-air from the list of qualifiers and will be notified via email.
 - i. To participate in the Promotion, you may go to one of four bar crawls, with all locations found on <https://www.facebook.com/pg/espnchicago/events/>. Visit the ESPN Chicago Street Team to get a raffle ticket and if your number is called, you will win a qualifying prize and be eligible for the grand prize. All entrants will receive one raffle ticket per bar crawl stop. GKB is not responsible for lost, stolen, mangled, misdirected, illegible, incomplete or late entries.
- c. Entries can only be made at each location during the times of the ESPN Chicago appearances. Only one entry per person per bar. All entrants must be present to win and accept prize.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 and who reside Illinois. Employees of GKB, its subsidiary and affiliated entities, GKB’s advertising and promotional agencies, its participating sponsors, [other radio stations in the Chicago metropolitan area, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.

- i. In the event a fan's raffle is pulled multiple times, they may receive multiple entries into the grand prize but only one qualifying prize.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. 12 qualifying prizes will be awarded in this Promotion. The prize consists of the following:

ESPN Chicago and White Claw Prize Pack

The Approximate Retail Value ("ARV") of the prize is \$50. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

1 grand prize will be awarded in this Promotion. The prize consists of the following:

Airfare for the winner and a guest to Phoenix, AZ
(2) nights in a hotel
\$500 Visa Gift Card
Tickets for (2) days to Spring Training

Airfare for 2 people to Phoenix, AZ from Chicago, IL from March 4, 2020 to March 6, 2020. The Prize also includes (2) nights in a hotel and a \$500 Visa gift card for additional transportation, meals, and spending money. The Approximate Retail Value ("ARV") of the prize is \$2,000. Certain travel restrictions may apply. Travel arrangements must be made through GKB. Prize is subject to availability. If the winner cannot travel on dates specified by GKB, the winner may be disqualified and an alternate winner may be selected in GKB's sole discretion. No transfer of grand prize permitted. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and ground transportation to/from the airport and/or to/from the hotel, are the responsibility of the winner. The winner and travel companion(s) must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental

expenses incurred during the winner's stay. The winner and travel companion(s) must sign a Publicity, Liability Waiver and Travel Release form prior to traveling. If a selected event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, or for any reason beyond the control of the Station, the Station's sole responsibility to the winner will be to award the remaining available portion of the prize and no substitution or compensation will be provided for the unawarded portion of the prize.

The gift certificate will be subject to the terms and conditions as set forth by the issuer of the gift certificate.

- b. All prizes will either be given to the winner on location or be sent to the winner by mail after signing the winner affidavit. GKB is not responsible for the safe arrival of a prize.
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Three qualifying winners will be selected on January 12, January 13, and two future dates to be confirmed.
- c. The final winner will be selected no later than February 19, 2020 at 5pm CT.
- d. Odds of winning a prize depends on the number of participants at each bar stop at each bar crawl.
- e. Qualifiers must be present to win. If name drawn does not check in within two minutes, an alternate winner will be named until a winner is found. The winner of the grand prize will be notified via email.
- f. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited and an alternate winner may be selected by email. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.
- b. By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize(s) or prize certificate(s), GKB, in its sole discretion, may require Promotion winner(s) (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless GKB, its subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.
- d. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the

control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.

- g. GKB is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
- h.
