

Dane County Fair Ticket Giveaways

OFFICIAL RULES

Contest:

ESPN Madison will execute a giveaway for three winners to receive two (2) Dane County Fair General Admission tickets along with two (2) Dane County Fair Complimentary Carnival Coupons. Followers of @ESPNMadison on Twitter can enter for the chance to win by responding back to ESPN Madison's tweet regarding the Dane County Fair and following @JumpAround1005 starting on Monday, July 8, 2019, at 5PM CST and going through Monday, July 15, 2019, at 5PM CST. TJ Hogan, Jim Rutledge, and Jade Vargas will randomly select three winners that have responded to ESPN Madison's tweet and follow @JumpAround1005 on Twitter. Entries must be submitted between 5PM CST on July 8, 2019 and 5PM CST on July 15, 2019.

1) HOW TO ENTER

- a) These rules govern the "Dane County Fair Ticket Giveaways" promotion (the "Promotion") being conducted by ESPN Madison, 15 N. Pinckney St, Suite 100, Madison, WI 53703 ("Good Karma Brands, LLC") beginning on Monday, July 8, 2019 at 5 PM CST and ending on Monday, July 15, 2019 at 5 PM CST.
- b) To participate in the Promotion, you may enter via the following method(s):
 - i) To participate in the Promotion, you may log onto www.Twitter.com ("Page") and if you do not already "Follow" the account, then you must "Follow" ESPN Madison on Twitter (www.Twitter.com/ESPNMadison) in order to access the Promotion. Comment/Respond to ESPN Madison's Tweet regarding the Dane County Fair and "Follow" The Jump Around (@JumpAround1005) on Twitter. You must have a valid Twitter account in order to enter and your Tweet Privacy must be set to un-protected. If you do not already have one, you can create a Twitter account at no cost by visiting <http://www.twitter.com>. Limit (1) entry per eligible person during the Entry Period regardless if entrant has more than one email address or Twitter account. Multiple participants are not permitted to share the same email address or Twitter account. Entries submitted may not be acknowledged or returned. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems.

- ii) Limit one entry per person. Entries are only accepted via Twitter submissions. All entries must be submitted by 5 PM CST on Monday, July 15, 2019 to be considered for the promotion.

2) ELIGIBILITY RESTRICTIONS

- a) The Promotion is open to all persons who are 18 years of age and older and who reside in the Greater Madison Metropolitan Area. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

The Approximate Retail Value (“ARV”) of each general admission pass is \$8.00 USD and of each carnival coupon is \$5.00 USD. The Approximate Retail Value (“ARV”) of the prize (2 general admission passes and 2 carnival coupons) is \$26.00 USD. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.
 - ii) All prizes or prize certificates may be picked up at the office of GKB at the address below. The winner will forfeit any prize or prize certificate not claimed within ten (10) days of winning. GKB is not responsible for the safe arrival of a prize or prize certificate.

- 4) 4. WINNER SELECTION AND NOTIFICATION
- a) Decisions of GKB management with respect to the Promotion are final.
 - b) Three (3) winners will be selected at random on The Jump Around by Jim Rutledge, TJ Hogan, and Jade Vargas on Monday, July 15, 2019 by 6 PM CST.
 - c) The final winner will be determined by Monday, July 15, 2019 on The Jump Around from 5 PM CST to 6 PM CST.
 - d) Odds of winning the Prize depends upon the number of entries received.
 - e) Winner does not need to be present to win or listen to 100.5 ESPN.
 - f) Winner will be announced on Monday, July 15, 2019 via Twitter. Winner will also be announced on ‘The Jump Around’ on 100.5 ESPN between 5 PM-6 PM CST on Monday, July 15, 2019. The winner will be contacted via direct message or a reply from the ESPN Madison account on Twitter. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited and the runner-up winner will be selected based on number of correct team predictions.
