

DEER DISTRICT VIP ALL ACCESS PASS GIVEAWAY

1. HOW TO ENTER

 - Tweet your best dad joke
 - Tag @ScalzoAndBurst and @DeerDistrictVIP
- i. To participate in the Promotion, you may visit Scalzo and Brust's Twitter Page: www.twitter.com/ScalzoAndBurst. You must tweet a dad joke and tag @DeerDistrictVIP and @ScalzoAndBurst to enter for a chance to win (1) NFT Pass. If you do not already "Follow" the Scalzo And Brust account, you must "Follow" the Scalzo and Brust account in order to be entered for a chance to win the "Promotion." 2. ELIGIBILITY RESTRICTIONS

 - Members will be able to use their code at allaccess.deerdistrict.com to redeem your member pass

The Approximate Retail Value (“ARV”) of the prize is \$350. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. All prizes or prize certificates will be emailed to the winner via the email address the winner provided. A GKB representative will email the winner a code redeemable at <https://allaccess.deerdistrict.com/>. Prize can be used for any 2022 Bucks playoff game. Winner will forfeit prize if not used before the end of the 2022 Bucks postseason run. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.

- a. Decisions of GKB management with respect to the Promotion are final.

- b. (2) winners will be selected each day beginning Thursday, April 21st, 2022, starting at 7:00am CST and ending Sunday, April 24th, 2022, ending at 6:00pm CST. Winners will be decided at the discretion of GKB.
- c. All final winners will be determined by Sunday, April 24th, 2022, at 6:00pm CST.
- d. Odds of winning a Qualifying Prize is up to the discretion of GKB. Each entry will be judged by GKB on the quality of their submission posted on Twitter.
- e. Qualifiers must “Follow” Scalzo and Bruston Twitter, tweet a dad joke, and tag @ScalzoAndBrust and @DeerDistrictVIP to win. Qualifiers and the Grand Prize winner need not be present to win.
- f. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited.
