#### 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are the age of 18 years and above and reside in Palm Beach County, Martin County or St. Lucie County (Florida). Employees of GKB, its subsidiary and affiliated entities, GKB’s advertising and promotional agencies, its participating sponsors, other radio stations in the Treasure Coast area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. - b. Winners will be randomly selected each week from the pool of entrants who completed the online form. All decisions in terms of prizing are determined by GKB.
- c. Odds of winning a prize depends upon the number of online entries and your ability to score more fantasy points than Mike Tannenbaum.
- d. Qualifiers must complete the online form and Fantasy League by specified date to win. Prize winners need not be present to win.
- e. Winners will be notified by an employee of GKB by the phone number or email they provided to the show producer. They will be informed within 72 hours of being selected the winner. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited and an alternate winner may be selected by running the promotion again on a different day.
