

Delzer ESPN Wisconsin Open – Fan Contest

OFFICIAL RULES

Contest

ESPN Milwaukee and ESPN Madison will execute Delzer ESPN Wisconsin Open – Fan Contest to give a fan the chance to play in this year's Delzer ESPN Wisconsin Open on Thursday, August 8th, 2019. To participate, fans may submit their favorite ESPN Wisconsin memory on Twitter using the #ESPNNMemories and tagging @ESPNNMilwaukee and @ESPNNMadison. Fans can also submit an online entry form by visiting espnwisconsincontests.com to be qualified. The winner will be chosen based on the story submitted and will be allowed to bring one (1) guest with them to play.

1. HOW TO ENTER

Pickney St., Madison, WI 53703 (“GKB”) beginning on Wednesday, July 10th, 2019 at 6am CST and ending on Friday, July 19th, 2019 11:59pm CST.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Twitter: Submit your favorite ESPN Wisconsin memory with #ESPNNMemories and tag @ESPNNMilwaukee and @ESPNNMadison.
 - Online Entry Form: Visit ESPNNWisconsinContests.com to fill out the entry form along with submitting your favorite ESPN Wisconsin memory.
- i. To participate in the Promotion, you may visit @ESPNNMilwaukee and @ESPNNMadison on the Twitter app. If you do not already “Follow” the Page, then you must “Follow” the Page in order to access the Promotion. You must have a valid Twitter account in order to enter. If you do not already have one, you can create a Twitter account at no cost by visiting <http://www.twitter.com>. Limit one (1) entry per eligible person during the Entry Period regardless if entrant has more than one email address or Twitter account. Multiple participants are not permitted to share the same email address or Twitter account. Entrants must submit their favorite ESPN Wisconsin memory using the #ESPNNMemories and tagging @ESPNNMilwaukee and @ESPNNMadison to be qualified to win a chance to play at the Delzer ESPN Wisconsin Open. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by GKB. Internet entrants are subject to all notices posted online including but not limited to GKB's Privacy Policy. Use of Twitter as a means of entry will be subject to Twitter's privacy policy and terms of service. By participating in the Promotion, entrant

understands that he or she is providing his or her information to GKB and not Twitter. Further, entrant specifically agrees to release Twitter from any and all liability associated with this Promotion. The Promotion is in no way sponsored, endorsed or administered by, or associated with, Twitter.

- ii. To participate in the Promotion, you may log onto <https://goodkarmabrands.com/wisconsincontests/> and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form. You must also submit your favorite ESPN Wisconsin memory in a text box to be qualified. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB's online submission release in order to submit his or her entry.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 years and older who reside in the state of Wisconsin. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the Milwaukee and Madison metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every thirty (30) days and only once every six (6) months if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.

- a. (1) grand prize will be awarded in this Promotion. Each prize consists of the following:

 - Round 18 for two including cart
 - Unlimited driving range for the day
 - Takeaway gift
 - Lunch
 - (2) drink tickets

 - Opportunity for additional prizes during the day of the outing

The Approximate Retail Value (“ARV”) of the prize is \$350 total. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. All prizes or prize certificates will be emailed to the winner. The winner must RSVP by Thursday, July 25, 2019 and will forfeit any prize or prize certificate not claimed by Thursday, August 8th, 2019. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.

- b. The winner will be selected on Monday, July 22th, 2019. The winner will be notified via email with an invite to the Delzer ESPN Wisconsin Open. The winner must RSVP with his/her guest name by Thursday, July 25th, 2019.
- c. Odds of winning depends on the number of entries and the discretion of ESPN Wisconsin as to which story is the best.
- d. Qualifiers must follow ESPN Milwaukee and ESPN Madison Twitter accounts to win. Qualifiers and the Grand Prize winner need not be present to win.
- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release by Thursday, July 25th 2019 or prize will be forfeited and an alternate winner may be selected. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
