

DELZER ESPN MILWAUKEE OPEN FAN CONTEST

OFFICIAL RULES

Fans may enter by subscribing to the ESPN Milwaukee YouTube channel, @945ESPNMilwaukee, and sending a screen shot showing proof of subscription to the ESPN Milwaukee Talk and Text line, 1-800-990-3776, between Monday, July 10, 2023, at 7 AM CST and Friday, July 14, 2023, at 6 PM CST during the ESPN Milwaukee shows, Jen, Gabe and Chewy from 7 AM CST and 9 AM CST, Homer and Tony between 2 PM CST to 4 PM CST, and Scalzo and Brust between 4 PM CST and 6 PM CST . There will be a total of 1 grand prize in the contest. The total ARV of the Grand Prize(s) is \$700.

1. HOW TO ENTER

- a. These rules govern the Delzer ESPN Milwaukee Open Fan Giveaway promotion (the "Promotion") being conducted by WKTI 94.5 ESPN Milwaukee, 301 W Wisconsin Ave, Suite 200, Milwaukee, WI 53203 ("GKB") beginning on Monday, July 10, 2023, at 7 AM CST and ending on Friday, July 14, 2023, at 6 PM CST.
- b. To participate in the Promotion, you may enter via the following method(s):
 - i. To participate in the Promotion, you must listen to WKTI 94.5 ESPN Milwaukee each day beginning on Monday, July 10, 2023, at and ending on Friday, July 14, 2023, between the hours of 7 AM CST and 6 PM CST during the ESPN Milwaukee shows, Jen, Gabe and Chewy from 7 AM CST and 9 AM CST, Homer and Tony between 2 PM CST to 4 PM CST, and Scalzo and Brust between 4 PM CST and 6 PM CST each day during the promotion dates for the on-air personality to announce the cue to text. Upon hearing the cue to text during the ESPN Milwaukee shows, Jen, Gabe and Chewy from 7 AM CST and 9 AM CST, Homer and Tony between 2 PM CST to 4 PM CST, and Scalzo and Brust between 4 PM CST and 6 PM CST listeners must subscribe to the ESPN Milwaukee YouTube channel, @945ESPNMilwaukee, and send a screen shot showing proof of subscription, announced on air to the ESPN Milwaukee Talk and Text line, 1-800-990-3776 to enter the Promotion. GKB is not responsible for telephone service outages, delays, equipment malfunctions or any other technological difficulties that may prevent an individual from sending a text message. Message and data rates may apply, and GKB is not responsible for any fees incurred by an entrant for this method of entry.

- a. Show times are subject to change based on breaking news and specialty content at the discretion of GKB. GKB has the right to not notify fans and to not update contest rules or the webpage when such situations occur.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 and over and who reside in the Greater Milwaukee Area. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

GKB accepts no responsibility for repairing any real or supposed damage to any prize. Winner must be able to attend the 2023 Delzer ESPN Milwaukee Open in order to be eligible to win.

b. Submission period will take place beginning at 7:00 AM CST on Monday, July 10, 2023, and closing at 6:00 PM CST on Friday, July 14, 2023, during the ESPN Milwaukee shows, Jen, Gabe and Chewy from 7 AM CST and 9 AM CST, Homer and Tony between 2 PM CST to 4 PM CST, and Scalzo and Brust between 4 PM CST and 6 PM CST.

c. The winner will be notified on Monday, July 17, 2023, following the closing of the submission period. All final winners will be known by 5:00p CT on Tuesday, July 18, 2023.

d. Odds of winning a Grand Prize depend on the number of submissions during the submission period.

e. Qualifiers and the Grand Prize winner need not be present to win.

f. The winner will be contacted either via phone call. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release Wednesday, July 19, 2023, or prize will be forfeited and an alternate winner may be selected.
