All entries must be received by the ESPN LA team with four (4) minutes remaining in each quarter during the game played on the respective Thursday Night Football dates (and Sunday, November 26, 2023 plus Saturday,

## 2. ELIGIBILITY RESTRICTIONS

Each qualifying prize winner will be announced live at The 909 during halftime of the respective Thursday Night Football dates (and Sunday, November 26, 2023 plus Saturday, December 23, 2023)
- c. Each winner will be selected during the 1K Thursday event during the promotion dates.
- d. Odds of winning a Prize depends upon the number and order of QR code entry form submissions received.
- e. Qualifiers must be present to win.
- f.
