There will be a total of 12 qualifying prizes AND 13 grand prizes in the contest. The total ARV of the Grand Prize(s) is/are \$100 dollars

1. HOW TO ENTER

- a. These rules govern THE ULTIMATE FANTASY FOOTBALL EXPERIENCE promotion (the “Promotion”) being conducted by ESPN LA – Good Karma Brands 800 W Olympic Blvd. Suite 100, Los Angeles, 90015 (“GKB”) beginning on Tuesday August 1st, 2023 at 12:00 PM PT and ending on Friday, August 4th, 2023 at 12:00 PM PT.
- b. To participate in the Promotion, you may enter via the following method(s): Register your 8 Team Fantasy Football League online at https://goodkarmabrands.com/blog/registration-page-fantasy_draft/ beginning on Tuesday August 1st, 2023 at 12:00 PM PT and ending on Friday, August 4th, 2023 at 12:00 PM PT.
 - i. To participate in the Promotion, you may log onto https://goodkarmabrands.com/blog/registration-page-fantasy_draft/ and follow the links and instructions to enter the Promotion and submit your first and last name, telephone number, email address, league name, and the other seven teams’ information in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB’s computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems.

c. To qualify 6/8 of the league's teams MUST be able to attend the Fantasy Draft Party at Hollywood Park Casino on Friday August 18th, 2023 at 6:30 PM PT

2. ELIGIBILITY RESTRICTIONS

3. PRIZES

Each week, the highest scoring team in the ESPN LA Gauntlet will receive \$100 in playing credits on their Hollywood Park Casino players card account. The Approximate Retail Value ("ARV") of the qualifying prize (12) is \$400. The Approximate Retail Value ("ARV") of the Grand Prize (13) is \$100. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. All prizes or prize certificates will be emailed to the winners. The winner will forfeit any prize or prize certificate not claimed within forty-five (10) days of winning. 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. The ESPN LA Fun & Games Department will begin qualifying the applicants on a first-come first served basis starting on Tuesday, August 1st, 2023 at 12:00 PM PT and concluding once twelve (12) leagues are completely filled. If no Leagues are filled before 12:00 PM PT on Friday, August 4th, 2023, then the ESPN LA Fun and Games Department will qualify teams at our own discretion.
- c. The final twelve (12) teams will be announced on Friday, August 4th, at 4:00 P PT. The grand prizes winners will be announced on a weekly basis following the conclusion of a respective NFL week.
- d. Odds of winning a Qualifying Prize depends upon the number and order of entries received. Odds of a Qualifier winning the Grand Prize are 1 in 96.
- e. If there is a tie at the end of a given week, the ESPN LA Fun and Games Department will flip a coin to decide a winner.
