

ESPN Cleveland Corona Flyaway Contest

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. HOW TO ENTER

- a. These rules govern the ESPN & Corona Extra ® Scan to Win promotion (the “Promotion”) being conducted by ESPN Cleveland, 1301 E 9th St, Suite 252, Cleveland OH 44114 (“GKB”) beginning May 9th, 2022 at 12:00am EST, and ending on June 30th, 2022 at 11:59pm EST.
- b. To participate in the Promotion, you may locate a Corona Extra ® QR code at participating locations in the Cleveland area to scan with a mobile device and follow instructions to enter the promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth, and a valid email address in the online entry form.
- c. A list of all participating locations can be found at www.ESPNClevelandContests.com.
- d. Only one internet entry per person and one internet entry per email address is permitted.
- e. There will be a total of one (1) winner randomly selected online for this Promotion upon confirmation of eligibility. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB’s computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems.
- f. Entrants must be 21 years or older as of date of entry to participate.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 and who reside in Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB’s advertising and promotional agencies, its participating sponsors, and the members of their immediate families

(spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win, as well as employees of Crown Imports LLC d/b/a Constellation Brands Beer Division ("Crown Imports") and its affiliates or suppliers, distributors or retailers of alcohol beverage products. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every thirty (30) days and only once every six (6) months if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize."
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. (1) Grand Prize will be awarded in this Promotion. The prize consists of the following:
 - (2) tickets to the Cleveland vs. Boston game on July 25th, 2022, at Fenway Park in Boston, MA
 - Airfare for winner and guest
 - (2) nights hotel stay for winner and guest in the greater Boston area
 - Exact flight dates, times, and hotel to be determined by GKB

The Approximate Retail Value ("ARV") of the prize is \$3,000. The winner will be solely responsible for all taxes and other fees and expenses not specified herein associated with the receipt and use of the Prize, including transportation to and from the airport. GKB accepts no responsibility for repairing any real or supposed damage to any prize. Airfare will be subject to the terms and conditions as set forth by the issuer of the airfare/passes. In the event that the game is cancelled or rescheduled due to COVID-19, GKB will award a cash prize of equal value.

- b. The Grand Prize will be used around the baseball game played between Cleveland and Boston scheduled for July 25th, 2022. GKB will make all final decisions relating to travel accommodations. To accept the prize, the winner must complete and return all required prize forms to GKB within (10) business days of being selected as the winner. Required prize forms include but are not limited to an Accepting Prize Form and W9. Any prize not accepted within (10) business days will be forfeited, and another eligible winner will be randomly selected in their place. GKB and Crown Imports are not responsible for the safe arrival of a prize or prize certificate. GKB and Crown Imports will not replace any prize or prize certificates once transferred to the winner.

- c. Certain travel restrictions may apply. Travel arrangements must be made through GKB. Prize is subject to availability. If the winner cannot travel on dates specified by GKB, the winner may be disqualified and an alternate winner may be selected in GKB's sole discretion. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and ground transportation to/from the airport and/or to/from the hotel, are the responsibility of the winner. The winner and travel companion(s) must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the winner's stay. The winner and travel companion(s) must sign a Publicity, Liability Waiver and Travel Release form prior to traveling. If a selected event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, or for any reason beyond the control of the Station, the Station's sole responsibility to the winner will be to award the remaining available portion of the prize and no substitution or compensation will be provided for the unawarded portion of the prize.
- d. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. There will be a total of one (1) Grand Prize winner selected during the Promotion dates. The winner will be randomly selected following the conclusion of the Promotion dates.
- c. The final winner will be determined following the third Promotional date.
- d. Odds of winning the grand prize depends upon the number of entries received, the ability to meet eligibility requirements, and random selection.
- e. Qualifiers need not listen to ESPN Cleveland to win. All prize winners need not be present to win.
- f. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release to GKB within (10) business days of being selected as the winner. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate,

suspend, or modify the Promotion and shall not be required to award a substitute prize.
