

ESPN DREAM TICKET PROMOTION

OFFICIAL RULES

There will be a total of 1 Grand Prize Winner in the contest. The total ARV of the Grand Prize(s) is \$1,752.

a. HOW TO ENTER

- a. These rules govern the ESPN Dream Ticket promotion (the "Promotion") being conducted by Good Karma Broadcasting, dba ESPN Los Angeles, 800 W. Olympic Blvd Suite 200, Los Angeles CA 90015 ("GKB") beginning on Monday, June 20th, 2022, at 9am Pacific time and ending on Friday, July 8th at 5pm Pacific time.
- b. To participate in the Promotion, you may go to any local grocery stores on Monday, June 20th starting at 9am Pacific time and ending on Friday, July 8th at 5pm Pacific time and follow instructions to text the keyword on brand product displays. All entries must be received by Wednesday, July 6th by 5pm Pacific time. GKB is not responsible for lost, stolen, mangled, misdirected, postage due, illegible, incomplete, or late entries.
 - i. To participate in the Promotion, the authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB's online submission release in order to submit his or her entry.

- ii. Sponsor is not responsible for winner notifications via texting that are the result of texting, computer or transmission errors and may cancel, modify or suspend the sweepstakes based upon any such error without liability at Sponsor's sole discretion. In the event that an error occurs and more than the designated number of prizes are claimed, the designated number of prizes will be awarded in a second round drawing from among eligible claimants.
 - iii. Odds of winning depend on number of valid entries received.
- c. Only one (1) entry per fan is permitted.

1. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are twenty-one (21) years or older and who reside in the United States. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
 - b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.

1. PRIZES

- a. One (1) Grand Prize will be awarded in this Promotion. Each prize consists of the following:
 - i. Four (4) tickets to a professional event on Monday, July 18th and Tuesday, July 19th in Los Angeles
 - 1. Two (2) tickets on Monday, July 18th.
 - 2. Two (2) tickets on Tuesday, July 19th.

b. The Approximate Retail Value (“ARV”) of the prize is \$1,752. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

a. All prizes or prize certificates will be electronically sent to the one (1) Grand Prize winner. The winner will forfeit any prize or prize certificate not claimed within forty-five (10) days of winning. GKB is not responsible for the safe arrival of a prize or prize certificate.

1. WINNER SELECTION AND NOTIFICATION

a. Decisions of GKB management with respect to the Promotion are final.

b. The Grand Prize winner will be randomly selected on Friday, July 8th, 2022, at 6pm Pacific time.

c. The Grand Prize winner will be determined on Friday, July 8th, 2022.

d. Odds of winning a Qualifying Prize depends upon the number of text entries received.

e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited, and an alternate winner may be selected by a number generator. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).

a. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
